On Thursday March 1, 1973 the City Council passed a resolution from your Committee regarding Neautaconkanut Park. This passage, of resolution #20 on the docket, leaves the Recreation Department in a mix up. Do we go ahead and schedule our softball leagues or do we wait for the Public Welfare Committee clearance on every night we intend to use it? The softball program is programed by the A S A in Rhode Island and we provide playing surfaces throughout the City for this Adult type recreation. This is all done at the lowest possible cost to the taxpayer. If we were to run a program of this magnitude it would cost the City thousands of dollars.

If you do have a meeting planned on the Neautaconkanut Complex, please consider inviting me. This type of legislation could set a precedent for our other recreation facilities in the City.
