SUBJECT: Referral No. 1772 - PETITION FOR ABANDONMENT OF McINTYRE COURT

Gentlemen:

This petition from the Committee on Public Works is a request for the abandonment of McIntyre Court which runs from 78 Jefferson Street for a distance of approximately 150' in a westerly direction.

Inspection revealed that McIntyre Court is a narrow uncurbed street. It provides access to a warehouse on Lot 725, a one family dwelling on Lot 724 and a 2-family dwelling on Lot 735. Lot 699 is vacant and unimproved. Revere Place is blocked by a fence at the lot line of Lot 699. A route through Lot 687 (which is vacant) is apparently also being used for access at present. The neighborhood is mostly residential and in fair to good condition.

Consultation with the Public Works Department has revealed that a private sewer line is located along McIntyre Court and that a water supply line is also located there.


Research revealed that the prime petitioner is St. Sahag and St. Mesrob Armenian Apostolic Church located at 70 Jefferson Street adjacent to McIntyre Court.

The Board of Trustees for the Church has requested that this petition be tabled as premature until purchase of all surrounding property is completed by the church in the near future at which time consideration may be more properly given by the Commission, therefore




As requested, we are supplementing our letter of May 15, 1970, relating to the Petition for Abandonment of McIntyre Court.

We find that our facilities in the street to be abandoned have a depreciated value of \$1,381.38.

If the buildings which were recently privately owned and presently occupied are demolished and the land is owned by the Petitioner we would have no objection to the requested abandonment provided that the Petitioner pay the depreciated value. However, he must make application to the Water Supply Board for a new service from Jefferson Street to replace the present service from McIntyre Court and pay cost of same. Also, all necessary changes to the interior piping of the building serviced from McIntyre Court to connect to the new service in Jefferson Street must be borne by the Petitioner.

We are filing a bill with the City Clerk's Office in the above amount and respectfully request that your Committee take no action on this matter until the Water Supply Board is assured of payment for the value of the depreciated facilities located in the section of the highway to be abandoned.




