RESOLVED, That the City Solicitor is hereby requested to prepare, cause to be introduced and to urge passage at the 1982 Session of the General Assembly of the State of Rhode Island of an Act for immediate consideration for enactment of enabling legislation to implement

A Public Safety Fee:

To be assessed to all existing tax exempt property in the City of Providence. The rate shall be fixed at Twenty (0.20) Cents per square foot of property.

First levels of all existing buildings on property are allowed as land mass. Additional levels shall be assessed at a rate of Ten (0.10) Cents per square foot of floor area on remaining levels.

NOW, THEREFORE, BE IT RESOLVED, That this Act shall take effect upon its passage and to be assessed this fiscal year at Twenty-five percent (25%) for the last quarter judgement and full year assessments thereafter.
