Mr. Carl Sullivan of the Postal Service Department, Annex Station in Providence advises me that the number 1 Kennedy Plaza for postal purposes has been assigned to the other end of the plaza, I believe to the Rhode Island Hospital Trust. What he suggested is that S & J 351, Inc. d/b/a Cafe Plaza use the number 99 Kennedy Plaza and that you be notified of same and have it cleared through you since that number is not being used by anyone.
