

RESOLUTION OF THE CITY COUNCIL

No. 670

Approved December 10, 1982

RESOLVED, DECREED AND ORDERED:

That the following streets (or portions thereof) as set forth on the attached map designated Exhibit A hereto;

VIZ:

- 1) Gaspee Street
from Smith Street to Exchange Terrace
- 2) Railroad Street
from Gaspee Street to Stillman Street
- 3) Francis Street
from Railroad Street to Exchange Terrace
- 4) Stillman Street
from Railroad Street to Gaspee Street
- 5) Promenade Street
from Stillman Street to Steeple Street and
from Park Street to Gaspee Street
- 6) Kinsley Avenue
from Park Street Bridge to Gaspee Street
- 7) Francis Street
from Gaspee Street to Hayes Street

having ceased to be useful to the public and are proposed to be abandoned as Public Highways subject to the Narragansett Electric Company being permitted to retain their present facilities in existing locations in said streets (or portions thereof), together with the right to inspect, maintain, operate and replace the same; New England Telephone being permitted to retain their present facilities in existing locations, together with the right to inspect, maintain, operate and replace the same and with 24 hour access to said facilities; and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, That the Director of Public Works be and he is hereby directed to cause a sign to be placed on the above-named streets (or portions thereof) abandoned as aforesaid, having thereon the words, "Not a Public Highway," and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway (or portion thereof), which has been abandoned who is known to reside within the State, and it is further

ORDERED, That the City of Providence execute and deliver to the State of Rhode Island and Providence Plantation ("State"), Providence & Worcester Realty Company ("P & W") and the National Railroad Passenger Corporation ("Amtrak") a certain agreement with respect to the continued maintenance of said streets (or portions thereof) and removal of snow and ice therefrom by the City, which said agreement has heretofore been executed by the said State, P & W and Amtrak or agreed to in principal by said parties, in consideration of said other parties thereto agreeing to forebear from taking any action which would preclude the continued use by the public over the former location of said streets (or portions thereof). Said agreement shall provide further that in the event that any real estate acquired by said other parties is a result of said abandonments, it shall be reconveyed to the City for street purposes. In the event the said streets (or portions thereof) are no longer needed for any reason whatsoever to accomplish the transactions contemplated by that certain agreement entitled "Providence Rail Relocation Project Cooperative Agreement" dated January 27, 1982 by and among the City, the State, P & W, Amtrak and a certain Master Property Conveyance Contract executed pursuant to said Cooperative Agreement, and it is further

ORDERED, That the Mayor is hereby authorized and directed for and on behalf of the City, to execute and deliver an agreement among the parties as set forth above, which said agreement shall be in such form, with such changes therein as may be approved by the Mayor so executing the same and such approval to be conclusively evidenced by his execution and delivery thereof, and by which the City agrees to be bound.



Dear Mrs. Mendonca:

Over the past three (3) years the City has worked closely with State and Federal agencies in an effort to achieve the timely implementation of this important project. The cooperation we have received from all concerned has brought within our grasp the achievement of a goal identified over four generations ago -- the removal of the "Chinese Wall" which has restricted the orderly growth of the Downtown.

To date, public hearings have been held and approvals given by the Federal Railroad Administration and State of Rhode Island. The City Council has approved an amendment to the Downtown Urban Renewal Plan to include Capital Center within its boundaries and has approved \$4.6 Million of Providence Redevelopment Agency funds to match approximately \$100-Million in Federal, State and private funds. In addition, the Council has recently approved the creation of the Capital Center Development District and a Commission empowered to guide the project to a successful conclusion. That Commission includes two (2) members of the City Council who have actively participated in the deliberations.

We are now in the final stages of completing the engineering documents so that a late 1982 construction date is projected. In order to meet our objectives, it is necessary that the Committees on City Property and Public Works meet to review and recommend to the full Council the approval of certain property transfers as well as street abandonments and dedications. It is noted that there are no financial costs to the City in acquisition, condemnation, or relocation of property, residences, or businesses.

In order to assist the Committees on City Property and Public Works in its review of these matters, the attached maps have been prepared which illustrate the following:





A field inspection revealed that all subject streets are improved with curbs, pavements and sidewalks. The circular roadway pattern constitutes Pershing Square between the State Capital and Union Station. The subject abandonments are part of the overall development plan of the Capital Center Project which was presented to the Commission on August 13, 1981. At that time, the Commission approved the plan as being consistent with the land use pattern established by the Master Plan for Downtown Providence.

Per our conversation last evening, enclosed are the materials relevant to the petition for abandonment of certain streets within the Capital Center Project area. In general, the materials are intended to achieve the following objectives:

1. Officially abandon the named streets.
2. Assures the continued use by the public of the former streets until they are needed for construction purposes.
3. Indicates the alternative circulation routes via new or temporary roads.
4. Provides for maintenance and snow removal by the City until the former roads are needed for construction purposes.
5. Requires the reconveyance of the former streets to the City in the event that they are no longer needed to accomplish the objectives identified in the Capital Center Plan.

As you know, the Committee on City Properties unanimously voted to recommend that the Council, at its December 2 meeting, authorize the Mayor to execute the Master Property Conveyance Contract. A draft of that resolution is attached for your


