

WHEREAS, It appears that federal funds are being used for political advantages for the Mayor,



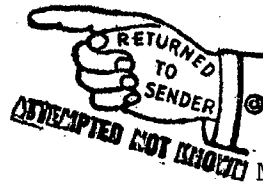
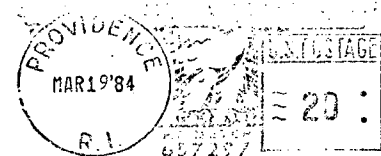
