Be it ordained by the City of Providence:

SECTION 1: The Zoning Map accompanying and made part of Chapter 544 of the Ordinances of the City of Providence approved September 21, 1951 as heretofore amended and entitled "An Ordinance Zoning the City of Providence and Establishing Use, Height and Area Regulations" is hereby further amended by changing from an R-3 General Residence Zone to a C-1 Limited Commercial Zone, Lot 37 as set out and delineated on City Assessor's Plat 67. Said lot being located at 36-38 Duke Street, bounded and described as follows:

Beginning at a point in the westerly line of Duke Street at the southeasterly corner of Lot 37 on Assessor's Plat 67; thence westerly along the northerly line of Lot 41 to the southwesterly corner of Lot 37; thence northerly along the easterly lines of Lots 512, 30, 31, 32 to the southwesterly boundary of the General Commercial Zone, C-2; thence southeasterly along the southwesterly boundary of the General Commercial Zone, C-2, to the westerly line of Duke Street; thence southerly along the said westerly line of Duke Street to the point and place of beginning.

SECTION 2: This Ordinance shall take effect upon its passage.




On the field trip it was found that the area is occupied by an insurance company and a newspaper distributor. A major portion of the lot is used for parking.






