Ms. Whaley was invited to the Finance Committee meeting of 08-19-04 via correspondence sent to her from Anna Stetson on behalf of Chairman Kevin Jackson.</p> <p>Ms. Whaley did not attend the Finance Committee Hearing on 08-19-04. She indicated in a letter of 09-13-04 that she did not receive the letter to appear at the Hearing as it was not mailed to her correct address. Please note, the address on file in the Human Resources Department on that date and currently is 314 Hope Street Bristol, RI, which is where the letter was sent.</p> <p>On 09-13-04 Ms. Whaley sent a letter of re-application of extension of residency to the City Clerk.</p> <p>On 11-15-04, Ms. Whaley contacted the HR Department inquiring whether or not she needed to attend the Finance Committee Hearing regarding her re-application for residency on 11-17-04. She then submitted correspondence to the City Clerk's Office indicating that she believed she did not need to attend the Finance Committee Meeting due to her ability to re-certify.(11-16-04)</p> <p>On 11-16-04, the HR Department verbally communicated to Ms. Whaley via telephone that she did in fact need to attend the hearing regarding her re-application.</p> <p>On 11-17-04, Sybil Bailey met with Ms. Whaley to communicate this again in person and followed up with a letter to her.</p>


RE: RE-APPLICATION FOR EXTENSION OF RESIDENCY
