



# RESOLUTION OF THE CITY COUNCIL

We will be cooperating with the NCAA, media and the civic center before and after the the "NCAA Frozen Four" hockey finals on April 6-8, 2000.



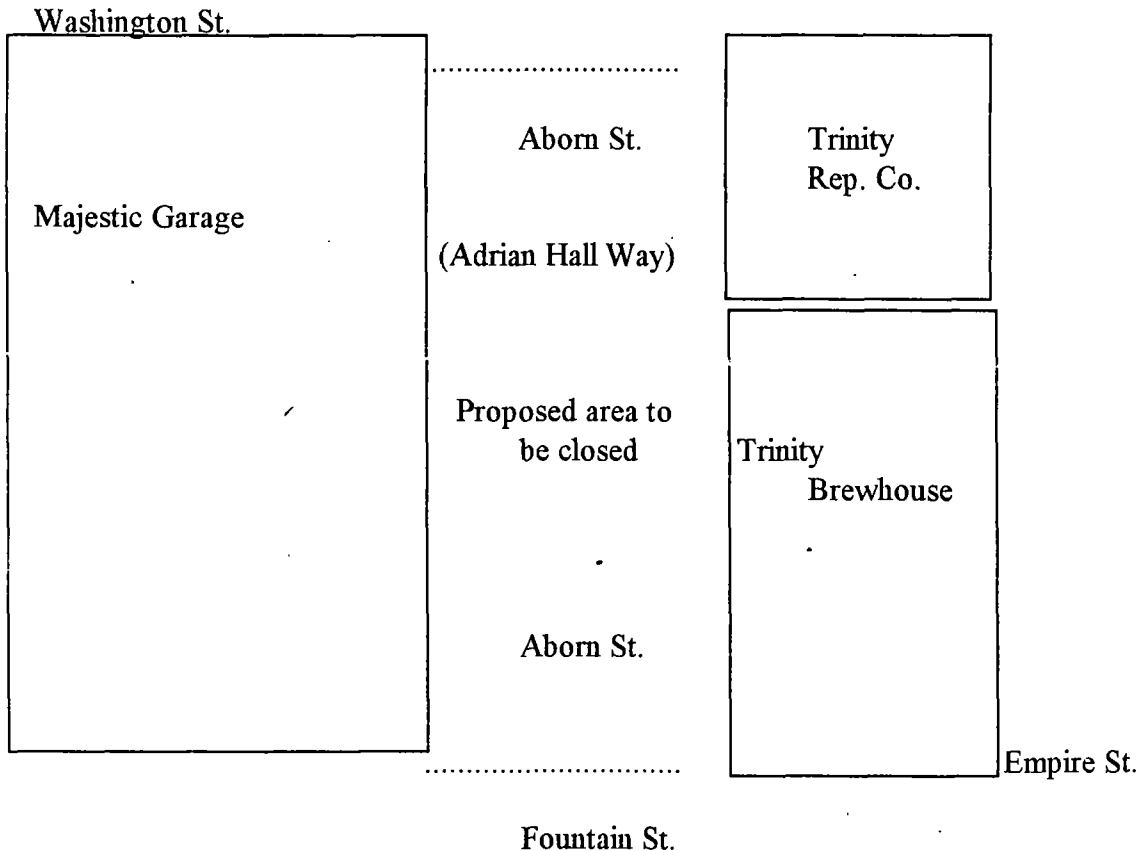

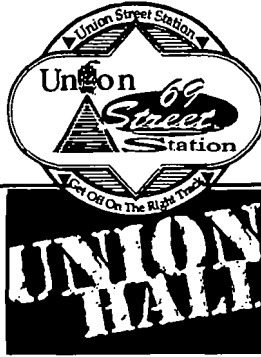
