

Gentlemen:

The Traffic Engineering Department has investigated the conditions at the intersection of Doyle and Morris Avenues, as requested in Council Resolution No. 162, dated March 11, 1957.

The results of the investigation that was conducted at this intersection indicate that there is a relatively low volume of traffic using both Morris and Doyle Avenues, and that there have been only 6 reported accidents in the past three years. Visibility of traffic approaching the intersection on Doyle Avenue by motorists stopped at the stop sign on Morris Avenue is hindered by the jog in the street alignment at the intersection, and the grade on the easterly leg of Doyle Avenue.

Even in view of these adverse conditions, the minimum warrants for the installation of signal control have not been met. Therefore, no traffic signals can be recommended for this location at this time.

Gentlemen:

The Traffic Engineering Department has investigated the feasibility of limiting parking on Cedar Street from Brayton Avenue to West Exchange Street, as requested by Council Resolution No. 373, dated May 17, 1957.

The use of the available parking space in the blocks along Cedar Street varies considerably in that in the section from Brayton to Dean there is a heavy concentration of all-day parking. The major part of this block is occupied by a City playground; and therefore the amount of commercial activity in this block is very small. The other four blocks covered by this resolution have a much lower concentration of all-day parking. In each block there are a few vacant lots which can be developed for parking purposes as the need for additional parking space arises. In each of these four studies, the investigation indicated on-street spaces were available at all times, and that there was a limited amount of all-day parking.

In view of the results of the investigations, it is recommended that no time limit parking be established on Cedar Street at this time.


Gentlemen:

The Traffic Engineering Department has investigated the petition concerning traffic conditions on Richmond Street between Ship Street and Weybosset Street.

Traffic volume counts made on various sections of Richmond Street between the limits stated indicate that there is a substantial increase in the volume of traffic using Richmond Street between the hours of 4 p.m. and 6 p.m. In addition to the increase in the total number of vehicles using the street, there is also an increase in the amount of bus activity as well as a considerable amount of loading and unloading activity, all of which serves to hinder the free flow of the traffic movement.

It is therefore the considered opinion of this department that the parking prohibition now in force between the hours of 4 p.m. and 6 p.m. on the northeasterly side of Richmond Street from Ship Street to Weybosset Street is a necessary regulation with respect to the safe, orderly, and efficient flow of traffic on this street.


Gentlemen:

The Traffic Engineering Department has investigated the parking conditions on Brayton Avenue from Atwells Avenue to West Exchange Street as requested in City Council Resolution No. 374 dated May 17, 1957.

Brayton Avenue is thirty feet wide from curb to curb, which is sufficiently wide to permit parking on both sides of the street and still allow vehicles to pass in both directions at the same time.

In view of the high demand for all types of parking in this section of Federal Hill, it is not recommended that parking be prohibited on one side of Brayton Avenue from Atwells Avenue to West Exchange Street at this time.


