No. **272 AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE

CHAPTER 1288 by APPROPRIATING THE SUM OF FIVE THOUSAND FIVE HUNDRED (\$5,500) DOLLARS TO POLICE DEPARTMENT, ITEM 5.

Approved May 20, 1960

Be it ordained by the City of Providence:

SECTION 1. Chapter 1288 of the Ordinances of the City of Providence as approved September 18, 1959, entitled: "An Ordinance Making Appropriation of \$39,301,585.32 for the Support of the City Government for the Fiscal Year Ending September 30, 1960", as amended, is hereby further amended by appropriating the sum of Five Thousand Five Hundred (\$5,500) Dollars to POLICE DEPARTMENT, ITEM 5.

SECTION 2. The said sum of Five Thousand Five Hundred (\$5,500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by Five Thousand Five Hundred (\$5,500) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.

THE NEW YORK, NEW HAVEN AND HARTFORD RAILROAD COMPANY (hereinafter called the Railroad Company) hereby leases to **the WATER SUPPLY BOARD, CITY OF PROVIDENCE, RHODE ISLAND**

(hereinafter called the Lessee) the right to install, use and maintain a certain construction, consisting of **an 8 inch cast iron water pipe on, across and under land and track of the Pontiac Branch of the Boston Division of the Railroad Company at about Engineering Station 22 + 85 of the monumented center line of the Railroad Company and located southerly of intersection of Harper Avenue and Forest Avenue, in Cranston, Rhode Island, substantially as shown in red on print hereto attached, made a part hereof and entitled: "N.Y.N.H. & H.R.R. CO. Boston Div. Pontiac Br. Proposed Water Pipe .32 Mi. West Of So. Auburn Cranston, R.I. Scale 1"-100' June 23, 1959"**,

upon the following terms and conditions:

1. The term of this lease shall date from **August 20,** 19 **59** and shall continue until terminated by a written notice given by either party to the other at least thirty days prior to the date of termination.
2. The Lessee shall pay to the Railroad Company as rent the sum of **Ten** Dollars **(10.00) per year** on the **twentieth** day of every **August** in advance, during the continuance of this lease (and pro rata for a shorter period), a proportionate part of said rent to be refunded to the Lessee in case of termination hereof by the Railroad Company by notice under the preceding paragraph prior to the date to which rent shall have been paid.
3. The Lessee shall install and maintain said construction to the satisfaction of the Railroad Company and under the Railroad Company's supervision and direction, and, except in case of emergency, shall do no work with reference to the maintenance or repair of said construction on the Railroad Company's premises except under such supervision and direction and after reasonable notice in writing to the superintendent of the division of the Railroad Company on which said construction is located.
4. The Lessee shall reimburse the Railroad Company for any and all expense that may be incurred by the Railroad Company in connection with the installation, maintenance or use of said construction.
5. The Lessee assumes all risk of loss of or damage to property and injury to or death of persons occurring on the premises of the Railroad Company or in connection with the use thereof, and shall indemnify and save harmless the Railroad Company from any and all suits, claims, demands or liens arising out of or resulting from the said loss, damage, injury or death, unless caused by the sole negligence of the Railroad Company, in which event the Railroad Company shall be solely liable, or by the joint negligence of the Lessee and the Railroad Company, in which event they shall be jointly liable and any resulting damage shall be borne by them equally.
6. The Lessee shall not by the installation, maintenance, use or removal of said construction in any way or at any time interfere with the safe passage of the Railroad Company's trains.
7. The Lessee shall on request of the Railroad Company and without expense to it, make such changes in said construction as may be required by the Railroad Company, if such changes shall in the judgment of the Railroad Company be needed in connection with the development or use of the premises of the Railroad Company.
8. On termination of this lease for any cause, the Lessee shall, without expense to the Railroad Company, remove said construction from the premises of the Railroad Company and leave said premises in a condition satisfactory to the Railroad Company.
9. The Lessee shall not assign this lease without the written consent of the Railroad Company.
10. This lease shall be binding upon and inure to the benefit of the legal representatives, successors and assigns of the parties respectively.




