Subject: Request for Crossing Guard at Admiral and Hawkins Streets

Sir:

Pursuant to your instructions, I have studied the attached copy of a petition recently submitted to the Honorable City Council of Providence by the Berkshire-Veazie-Valley View P.T.A. in request for the assignment of a school crossing guard at the intersection of Admiral and Hawkins Streets.

I noted that the petition cites a total of 195 children of young age who are directly involved in school crossings at this intersection which is situated one-half mile southeast of the Veazie Street School. I suspect that there are probably more children whose parents could not be reached by the PTA group in its quest for petition signatures which would have brought this total even higher. The school enrollment is of sizeable proportion.

The petition shows considerable effort and time taken in study of a local community problem which I also consider to be a police problem. The problem is that of providing guard and control of one intersection which is part of Eagle Park Square, a complex intersection highway system of some expanse through which traffic flows from and along Admiral St., Hawkins St. and Douglas Ave. This square is situated in a general commercial zone and has long been a focal point for much of the vehicular and pedestrian traffic in the north end of the city.

Traffic controls now existing in this square consist of a boulevard stop sign located at the west end for eastbound traffic on Admiral St. entering the square. A traffic "yield" sign requiring north and westbound traffic on Admiral St. to yield to north and southbound traffic on Douglas Ave. through the square itself is located in the center; it is at a point, however, just west of the intersection in question and provides no effective control over traffic entering or leaving Hawkins St.

I have visited the intersection and observed the transit of busses and other large vehicles in entering and leaving Hawkins St. and found that petition comment about the movement of such vehicles is substantially correct. The driving of such vehicles through the intersection is necessarily slow as operators negotiate turning movements on the narrow confines of Hawkins St.

I also observed that patrolmen assigned to the three motor patrol posts adjoining at Eagle Park Square appear to regard it as a location requiring particular traffic law enforcement activity. One of these officers can usually be found parked nearby observing traffic. I regard this action of these officers as a fairly good barometer of traffic enforcement needs in this area.


Sir:

Gentlemen:

It is urgently requested that a crossing guard be located at the corner of Admiral and Hawkins Streets.

There will be four daily trips to the Veazie Street elementary school which has an enrollment of approximately seven hundred(700) pupils many of whom walk one mile to and from school. The Admiral-Branch Bus is compelled to execute weaving movements when entering and leaving Hawkins Street. This newly created pedestrian hazard and diagramed report which accompany this letter is cause for parents to become gravely concerned about the urgent need for a crossing guard at this "T" intersection.

The class arrangement at the Berkshire Street school which has an enrollment of approximately three hundred (300) pupils has been altered and for the first time does not include a third grade. Lower grade pupils averaging eight years of age are being forced to use the presently uncontrolled and unguarded intersection to attend Veazie Street school.

Enclosed is a list of parents names whose children are directly involved.
