The City Plan Commission at its regular meeting on Tuesday, March 16, 1999, reviewed and evaluated the request from the Committee on Public Works on the petition to abandon the above cited streets located in the Hartford neighborhood.

The petitioner is the Providence Redevelopment Agency who together with the Providence Public Buildings Authority is working to develop a site for a new 800 student middle school and a 400 student elementary school. The parcels (about 121 lots) and the abandoned street area will be merged into a single parcel, which would total approximately 10 acres.

During the City Plan Commission meeting, Hartford residents as well as city officials discussed the various existing conditions and ownership of the lots in question. The discussion lead to the re-draft of the presented project boundary, as submitted by the department. The re-drawn project boundary as shown on the Public Works Department Street Line Plan, is attached to this decision for submission to your committee.

The Commission has reviewed and evaluated the request for consistency with the City's Comprehensive Plan. The Commission found the proposed abandonment of said right-of-ways is consistent with *Providence 2000: The Comprehensive Plan*.

The City Plan Commission voted to recommend that the Committee on Public Works approve the petition to abandon the aforesaid public right-of-ways after the condemnation process is complete.


