Be it ordained by the City of Providence:

SECTION 1: Chapter 1051 of the Ordinances of the City of Providence approved September 20, 1956, entitled: "An Ordinance Making Appropriation of \$33,514,967.90 for the Support of the City Government for the Fiscal Year Ending September 30, 1957", as amended, is hereby further amended by adding the sum of Twenty Five Hundred (\$2500) Dollars to the appropriation contained therein for WATER FUND-TAXES, ITEM 3.

SECTION 2: The said sum of Twenty Five Hundred (\$2500) Dollars as thus added and appropriated shall be obtained by transferring a like amount from Water Fund-Payment to Sinking Fund.

SECTION 3: This Ordinance shall take effect upon its passage.




