*Approved* August 18, 1989

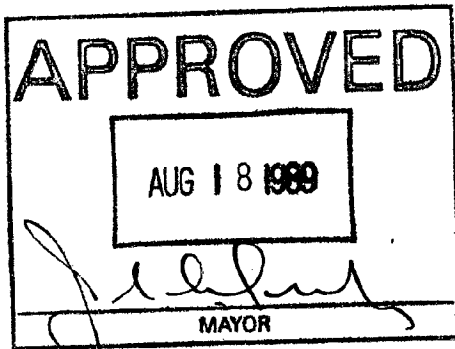
RESOLVED, that His Honor, The Mayor, is hereby authorized to execute a Lease of part of Lot 74 on City Assessor's Plat 1, located along Selkirk Street, which is more fully outlined in the attached description, said lot to be leased to Duane D. Lockaby, d/b/a Lock's Auto Sales, of Pawtucket, Rhode Island for the sum of Seventy-Five (\$75.00) Dollars per month for a one (1) year period, with option to renew for four (4) additional one (1) year terms with rental to be negotiated at that time and with such other terms and conditions as have been imposed by the Committee on City Property, the City Council, the City Solicitor, and His Honor, the Mayor.

This Resolution rescinds Resolution No. 260, approved May 6, 1988.

Beginning at a point in the easterly boundary line  
in the City of Providence and the City of Pawtucket;

Thence running generally westerly along an arc having  
a radius of thirty nine and forty-two hundredths feet  
(39.42') to a point of tangency;

Thence running generally northerly along an arc having  
a radius of four feet (4') to a point of tangency;

Thence running generally northerly along an arc having a  
radius of two thousand six feet (2,006') to a point;

Thence running easterly a distance of plus or minus  
four feet (4') to a highway bound in the Providence  
and Pawtucket boundary line;

Thence running generally southerly a distance of one  
hundred twenty seven plus or minus feet (127 ') to the  
point and place of beginning.

Said parcel contains 1,575 Square feet.
