AMENDING THE CITY OF PROVIDENCE ZONING ORDINANCE CHAPTER 1994-24 NO. 365, APPROVED JUNE 27, 1994.

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1994-24, No. 365, approved June 27, 1994 shall be amended as follows:

Section 103 - Official Zoning Map, by changing the zoning designation on Providence Zoning District Map 70, Lot 589 from C-1 Limited Commercial to C-2 General Commercial.

SECTION 2. This Ordinance shall take effect upon its passage.





PROPOSED ZONING CHANGE ADMIRAL STREET




LEGEND

EXISTING C-1 TO BE CHANGED TO C-2


EXISTING ZONING DISTRICT BOUNDARY

Dear Councilman James A. Petrosinelli,



