**No. 55 AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE

CHAPTER 1051, BY APPROPRIATING THE SUM OF FIFTEEN THOUSAND  
(\$15,000) DOLLARS TO POLICE DEPARTMENT, ITEM 5.

*Approved* January 18, 1957

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 1051 of the Ordinances of the City of Providence as approved September 20, 1956, entitled: "An Ordinance Making Appropriation of \$33,514,987.90 for the Support of the City Government for the Fiscal Year Ending September 30, 1957", as amended, is hereby further amended by appropriating the sum of Fifteen Thousand (\$15,000) Dollars to POLICE DEPARTMENT, ITEM 5.

SECTION 2: The said sum of Fifteen Thousand (\$15,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Fifteen Thousand (\$15,000) Dollars.

SECTION 4: This Ordinance shall take effect upon its passage.

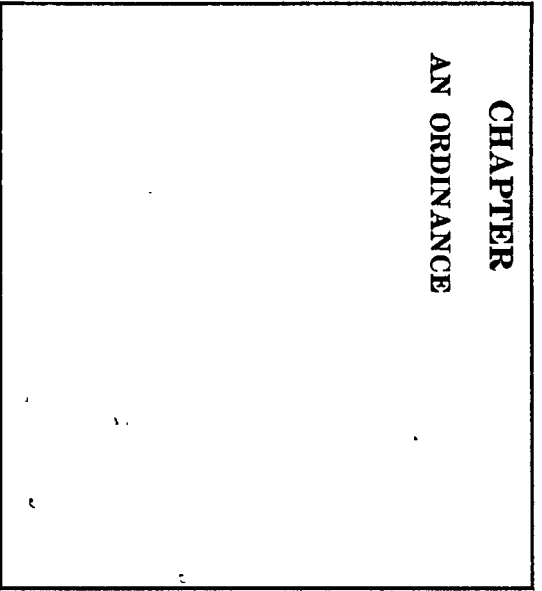

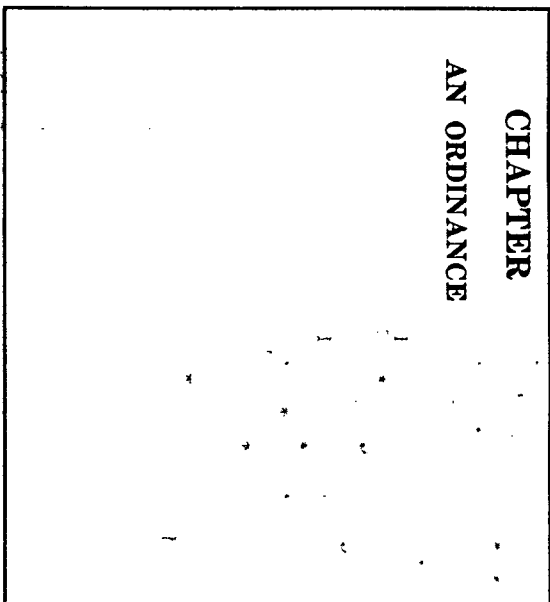

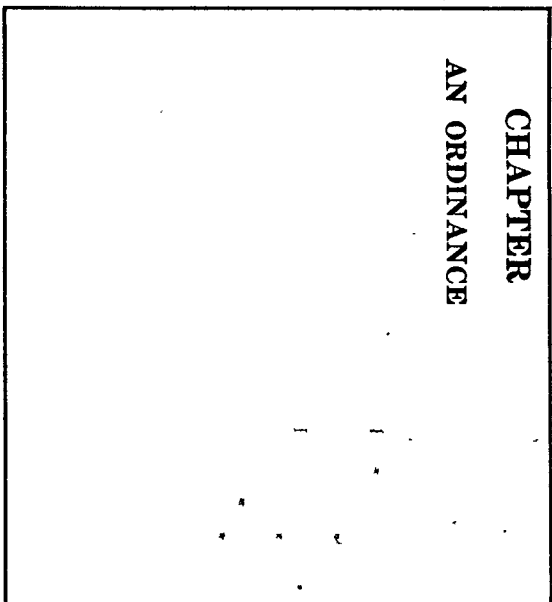
