RESOLUTION OF THE CITY COUNCIL

No. 467

Approved August 17, 1965

WHEREAS, the City of Providence will, within a short period of time, dedicate the first permanent pedestrian mall in the State of Rhode Island, and

WHEREAS, since the greatest portion of this mall has been placed upon a portion of Westminster street, so named since early in the nineteenth century, and

WHEREAS, it is the sense of His Honor Joseph A. Doorley, Jr. and of the members of the City Council that the Mall's identity and the name of Westminster street be analogous,

NOW THEREFORE BE IT RESOLVED, That the area, as hereinafter defined from that certain portion of Westminster street from the southwesterly line of Dorrance street, southwesterly to the north-easterly line of Snow street and that certain portion of Union street from the northwesterly line of Weybosset street northwesterly to the present southeasterly line of Westminster street and from the present northwesterly line of Westminster street northwesterly to the range of the southeasterly line of Fulton street, be designated and appropriately dedicated as "Westminster Mall".
