Approved April 19, 1957

Whereas, it is the policy of this locality to eliminate substandard and other inadequate housing, to prevent the spread of slums and blight, and to realize as soon as feasible the goal of a decent home in a suitable living environment for all of its citizens; and

WHEREAS, the United States Housing Act of 1937 as amended, provides that there shall be local determination of need for low-rent housing to meet needs not being adequately met by private enterprise; and

WHEREAS, low-rent housing is needed to assist in meeting the housing goal of this locality; and

WHEREAS, amendments to the United States Housing Act enacted by the Congress in 1956, make supplementary provisions for the housing of elderly persons, including single elderly persons, in low-income public housing developments; and

WHEREAS, it has been determined that, in the City of Providence, there is an urgent need for providing decent, safe and sanitary dwelling accommodations within the financial reach of such persons; and

WHEREAS, The Housing Authority of the City of Providence, Rhode Island and the Public Housing Administration have indicated a willingness to undertake the development of a program for the housing of such persons; and

WHEREAS, the application of The Housing Authority of the City of Providence, Rhode Island as required by said United States Housing Act, was heretofore approved by the City Council of the City of Providence on September 16, 1949;

WHEREAS, under the Housing Act of 1954, the United States of America (herein called the "Government") has tendered to City of Providence, an Offer, hereinafter mentioned, to make a demonstration grant to the City of Providence to aid in financing a project, designated Project No. R. I. D-1, and

WHEREAS, the City of Providence has given due consideration to said Offer.

BE IT RESOLVED, By the City Council of the City of Providence as follows:

SECTION 1. The Offer of the Government to the City of Providence dated March 21, 1957, designated Contract No. R. I. D-1(G), consisting of Parts I and II, under and subject to the provisions, terms and conditions of which the Government would make grant to the City of Providence to aid in financing the cost of a project, designated Project No. R. I. D-1, situated in Providence, Rhode Island, (College Hill Section), is hereby in all respects accepted.

SECTION 2. The City of Providence agrees to abide by all of the provisions, terms and conditions of said Offer.

SECTION 3. Authority is granted to the officers and duly appointed agents of the City of Providence to send to the Housing and Home Finance Agency, certified copies of this and such further documents or proofs in connection with the acceptance of said Offer as may be requested by the Government, and to file requisitions, together with necessary supporting documents, with the Government, from time to time as grant funds are required, requesting payments to be made to the City of Providence on account of the grant provided for in said Offer, and to do and perform all other things and acts required to be done or performed in order to obtain such payments.

SECTION 4. This Resolution shall be effective upon its passage.
