RESOLUTION OF THE CITY COUNCIL

No. 46

Approved February 12, 1982

WHEREAS, In December of 1981, Congress approved a \$569 Million Amtrack subsidy which included a proviso forbidding the railroad to use its money to pay local or state taxes, and

WHEREAS, This congressional action will cost the City of Providence to lose \$581,000 in tax revenue, notwithstanding other communities in our State, who will lose thousands of dollars,

NOW, THEREFORE, BE IT RESOLVED, That Rhode Island's Congressional Delegation is hereby requested to introduce legislation to eliminate the Property Tax Exemption to Amtrack.


Dear Ms. Mendonca:

Dear Ms. Mendonca:

Thank you for sending me a copy of Resolution Number 46 regarding the AMTRAK property tax exemption recently adopted by the Congress.

I certainly recognize the problem this exemption creates for Rhode Island's cities and towns, which are already hard-pressed by declining tax revenues and severe cuts in federal programs. The tax exemption is particularly unfair to the Northeast, which is the only region where AMTRAK actually owns its right-of-way. Outside the Northeast Corridor, AMTRAK leases the right-of-way from tax paying private railroads. The Northeast is AMTRAK's strongest revenue base, and should not shoulder the unequal burden of this tax exemption simply because of the happenstance of AMTRAK owning rather than leasing its right-of-way.

I intend to urge the Senate Appropriations Committee to rescind the exemption, except to the extent that AMTRAK property is actually improved with taxpayer subsidies. I will also strongly oppose the inclusion of this exemption in any future AMTRAK legislation.

In my view, a strong national rail passenger network is absolutely essential. The tax exemption, however, is not the right way to help AMTRAK, and adds to the difficult fiscal problems facing our cities and towns. I appreciate learning of your concern with this problem, and will do my best to be of some help to the cities and towns in this issue.


Thank you for writing on behalf of the Providence City Council concerning the recent tax exemption provided to the AMTRAK Corporation.

The amendment which provided the controversial tax break was added to the Department of Transportation's appropriation legislation when this measure was being considered in the United States Senate. It is ironic that at a time when the current Administration is advocating a greater role for local governments that the Senate would pass a provision which will negatively impact on your community's ability to operate efficiently.

For my part, I will certainly do all I can to seek legislative and administrative remedies to the problems we face. I am encouraged to note that both our Rhode Island Senators will jointly seek to reverse the Senate action which is the cause of the current situation.
