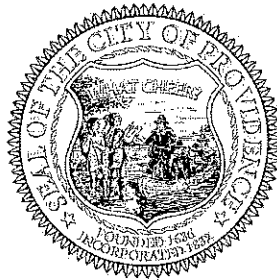

WHEREAS, In previous elections, to the knowledge of the Providence City Council, these bake sales enhanced the voting experience with disrupting or detracting from it in any way; and

WHEREAS, In the most recent election the Rhode Island Board of Elections imposed a new prohibition on the holding of any PTO food and/or beverage sales on Election Day.

PERSONAL EXPRESSION

COUNCILMAN NARDUCCI Requests the privilege of the floor to speak on a Point of Personal Expression and states:

"Last week we had a very sad incident on Plainfield Street where a great young man was killed by a hit and run driver on a motorcycle, Alexis Morales. He was a great young man. I thought it was very important tonight to bring it up because of two reasons. One, I knew him personally. He was a member of the Torque Ryders Motorcycle Group and what a group of guys they are. If you have never met them, reach out to them. The President lives in my neighborhood and anytime we need something from them or whenever we need to have food drives for our needy families or presents for the kids Christmas, Mr. Morales and Mr. Yohan were the first two Torque Ryders there. Roughly, about two weeks ago, we presented them with a plaque at the wine tasting that we had for Providence Animal Control because of what they've done organizing bike rides to raise thousands of dollars for Providence Animal Control, to help support products that the city can't buy because of the funding that this group raised thousands of dollars even for our animals. I find it very important right now to keep Alexis mom and the rest of his family in our prayers because we all know it's tough when you lose somebody, but losing somebody so close to the holidays and being a parent, we all know that it's not supposed to be that way. He was using his motorcycle that night to go to work and come back from work because when he got into his car his car didn't start and he didn't have any time to fix his car. He was a mechanic and he didn't have any time to look at his car because he had to get to work. Coming home from work is when that tragic accident happened and I just want to say how sad it is that any human being could hit somebody like that and take off and the once you find out your car has been destroyed and your license plate was left the scene of the accident to go back to the scene of the accident and look for your license plate not to find out how the young man was that you just hit. Again, I would like to just keep the Morales family in our thoughts and in our prayers. Alexis, we're going to miss you man."


