Now therefore, be it resolved that the taxes, in the amount of Four Hundred Forty Seven Dollars and Forty Two Cents (\$447.42), assessed upon Assessor's Plat 49, Lot 519 (348 Bucklin Street), along with any associated interest, penalties and intervening taxes are hereby abated in whole in accordance with Rhode Island General Law 44-7-23 and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40.
