Dear Ms. Mendonca:

Please be advised that City Council Resolution #524 requesting the Rhode Island Public Transit Authority to install bus shelters at Atwells Avenue, opposite Joe Acorn's Market and another opposite Rialto Furniture has been rejected by our Safety Department.

In order to have a safety approved bus shelter location, a four foot pedestrian right of way must exist at each location. Because the above site locations do not meet this criteria a safety hazard would exist for pedestrians walking on this narrow sidewalk.
