



RELATING TO THE CITY OF PROVIDENCE

Introduced By: Senators Perry, Goodwin, Ruggerio, DaPonte, and F Caprio

Date Introduced: February 13, 2003

Referred To: Senate Commerce, Housing & Municipal Government

It is enacted by the General Assembly as follows:

- 1-1 SECTION 1. The city of Providence is the owner of certain property (the "Premises")
1-2 located on Wheaton Street in said city described as follows:
1-3 Beginning at a point in the westerly line of Wheaton Street at the southeasterly corner of
1-4 said lot and at the northeasterly corner of land now or lately of Anna Karet, said point of
1-5 beginning being located approximately seventy-eight and 5/10 (78.5) feet northerly from the
1-6 point of intersection of said Wheaton Street with the northerly line of South Court Street; thence
1-7 westerly bounding southerly on said Karet land seventy-one and 35/100 (71.35) feet, more or
1-8 less, to land now or lately of Nettie Gertz; thence northerly bounding westerly on said last named
1-9 land in part and in part on land now or lately of Lenox Realty Company fifty-seven and 6/100
1-10 (57.06) feet, more or less, to land lately of The Yearly Meeting of Friends for New England;
1-11 thence easterly bounding northerly on said last named land seventy-one and 30/100 (71.30) feet,
1-12 more or less, to Wheaton Street; thence southerly bounding easterly on Wheaton Street fifty-two
1-13 and 70/100 (52.70) feet, more or less, to the point of beginning. Being the second parcel
1-14 described in that certain deed from the Rhode Island Roger Williams Memorial Association
1-15 recorded in the Providence Land Evidence Records in Deed Book 838 at page 114.
1-16 The Premises is subject to the requirement that it be used as a Parkway Approach to the

1-17 Roger Williams Monument on Prospect Terrace in said city and as a Memorial of Roger Williams
1-18 pursuant to section 1 of chapter 1034 of the January session, 1941 Public Laws entitled "An Act
1-19 Authorizing the Rhode Island Roger Williams Memorial Association to convey to the city of
2-1 Providence certain lands to be held by said city."

2-2 It is no longer in the best interest of the city of Providence to continue to own the
2-3 premises subject to said restriction, the city is hereby authorized, notwithstanding said chapter
2-4 1034, R.I.G.L. section 45-2-6 and any general law to the contrary to sell, convey, or lease, the
2-5 Premises free of said restriction and the sale, lease, and ownership and occupancy by said city or
2-6 other party is subject to the following requirements:

2-7 1. The proceeds from any conveyance, lease, or sale of the premises by the city or the
2-8 Providence Redevelopment Agency shall be placed in a trust fund administered by Board of Park
2-9 Commissioners and the income from such fund shall be used to maintain the Mary Elizabeth
2-10 Sharpe Park located between Wheaton Street and Benefit Street and Prospect Terrace Park
2-11 provided that not less than seventy-five percent (75%) of the income shall be allocated to the
2-12 former park.

2-13 2. No structure shall be constructed on the Premises other than retaining walls and fences.

2-14 3. The paved area on the premises shall not be increased and no more than ten (10) cars
2-15 shall be parked thereon. No public parking shall be permitted.

2-16 4. An evergreen screen shall be maintained along the northerly border of the premises.

2-17 SECTION 2. This act shall take effect upon passage.
