1 SECTION 1. Any city or town which enacts any ordinance or regu-  
2 lation relating to dumping on vacant land may impose penalties for the

4 exceed one thousand dollars (\$1,000) or one (1) year imprisonment, or  
5 both.

6 SECTION 2. This act shall take effect upon passage.
