KNOW ALL MEN BY THESE PRESENTS

That the City Of Providence, a municipal corporation created by the General Assembly of the State of Rhode Island and located in the County of Providence in said State, hereinafter called the Grantor, does hereby grant, bargain, sell and convey unto the PROVIDENCE REDEVELOPMENT AGENCY, a body corporate and politic organized under the laws of the State of Rhode Island, hereinafter called the Grantee, its successors and assigns forever the following described parcel of land.

That certain tract of land with all the building and improvements thereon, situated in the City of Providence, State of Rhode Island, bounded and described as follows:

Beginning at the angle point on the northerly line of Wickenden Street said point being one hundred and 00/100 (100.00) feet easterly from the intersection of the said northerly line of Wickenden Street and the easterly line of Traverse Street;

thence turning an interior angle of ninety degrees no minutes no seconds (90°00'00") with the aforementioned northerly line of Wickenden Street and running northerly along the easterly boundary of land now or lately of Allen C. Dudley and wife Doris seventy two and 00/100 (72.01) feet to a point;

thence turning an interior angle of eighty seven degrees twenty two minutes ten seconds (87°22'10") and running along the southerly boundary of land now or lately of Albert Perry and Maria T. and Central Congregational Church twenty three and 51/100 (23.51) feet to an angle point;

thence turning an interior angle of one hundred seventy four degrees fifty nine minutes fifty seconds (174°59'50") and running along the southerly boundary of land now or lately of central Congregational Church and John F. Delgado and wife Justina S. forty and 36/100 (40.36) feet to a point;

thence turning an interior angle of ninety degrees fifty minutes no seconds (90°50'00") and running along the westerly boundary of land now or lately of Jose B. Caldeira and wife Maria H. sixty six and 11/100 (66.11) feet to a point on the aforementioned northerly line of Wickenden Street;

thence turning an interior angle of ninety six degrees forty eight minutes no seconds (96°48'00") and running along the aforementioned northerly line of Wickenden Street fifty five and 43/100 (55.43) feet to the point and place of beginning.


