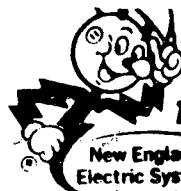

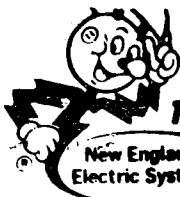

Sir:

I have considered the attached City Council resolution requesting the assignment of a patrol officer exclusively to the confines of Roger Williams Park on a twenty-four hour basis. I do not think the action cited by this resolution is warranted at this time for the following reasons.

Patrol officers assigned to Car 11, the unit covering the Park area, presently spend 95 percent of their available patrol time in the Park and the rest on streets which lead directly to Park property. Compliance with this request would necessitate extending the boundary lines of the several adjoining posts to provide coverage of the perimeter residential area streets and Washington Park Square's commercial establishments.

Such adjustment of adjoining post outlines would be impractical because of the nature of the area which makes up these posts. Each of the cars covering this area is already serving heavy workloads produced by criminal and non-criminal incidents, and calls for other types of police service. Any additional territory will add to the duties and responsibilities of the men in these cars and reduce their effectiveness and efficiency in their already-busy districts. Giving them more area to cover will enlarge the complaint posed in the resolution. Another alternative is to create a new car post in this general vicinity; as you are aware, this measure is precluded by the existing manpower shortage.

I have discussed this matter with commanding officers and necessary orders and instructions are being given to personnel assigned to the Park calling for increased vigilance to prevent incidents of the type alleged in the resolution. Moreover, I have directed that Traffic Bureau personnel patrolling adjacent Broad St. and Elmwood Ave. are to cruise the Park in criss-cross fashion at every available opportunity.





Gentlemen:

In response to a Resolution to establish a crossing guard post at the intersection of Academy Avenue and Whitford Avenue, a survey was conducted. The results do not indicate a need for such a post. The number of children crossing this area in the morning numbered nine and a total of thirteen in the afternoon. Traffic was not heavy at either time. At the corner of Academy Avenue and Smith Street, traffic is controlled by a traffic light. Children attending Nelson Street School have the protection of a crossing guard at Smith and Nelson and one at Smith and Elmhurst for those attending schools in the Elmhurst area.

I agree with the recommendation of the Chief of Police that such a post should not be established.
