CHAPTER 886 BY APPROPRIATING THE SUM OF FIVE HUNDRED (\$500.00)

*Be it ordained by the City of Providence:*

SECTION 1: Chapter 886 of the Ordinance of the City of Providence as approved September 17, 1954, and entitled: "An Ordinance Making Appropriation of \$30,448,534.47 for the Support of the City Government for the Fiscal Year Ending September 30, 1955", as amended, is hereby further amended by appropriating the sum of Five Hundred (\$500.00) Dollars to the DEPARTMENT OF RHODE ISLAND DISABLED AMERICAN VETERANS CONVENTION.

SECTION 2: The money hereby appropriated shall be paid to the Treasurer of the 1955 Department of Rhode Island Disabled American Veterans Convention Committee, to help defray expenses of the Annual State Convention of the Department of Rhode Island Disabled American Veterans to be held in the City of Providence, June 23rd, 24th and 25th.

SECTION 3: The said sum of Five Hundred (\$500.00) Dollars as hereby appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 4: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by the sum of Five Hundred (\$500.00) Dollars.

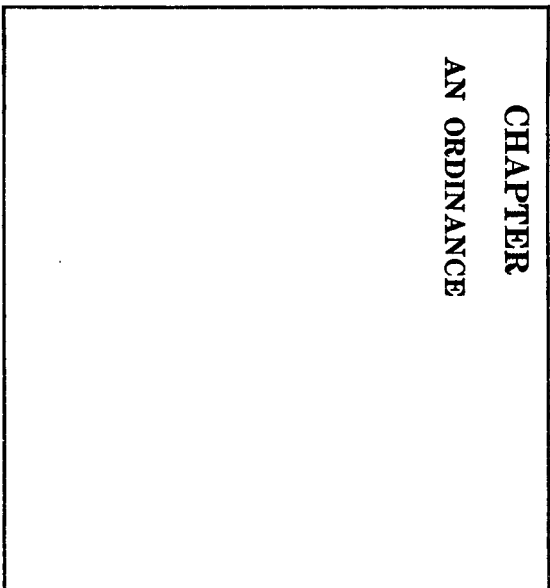

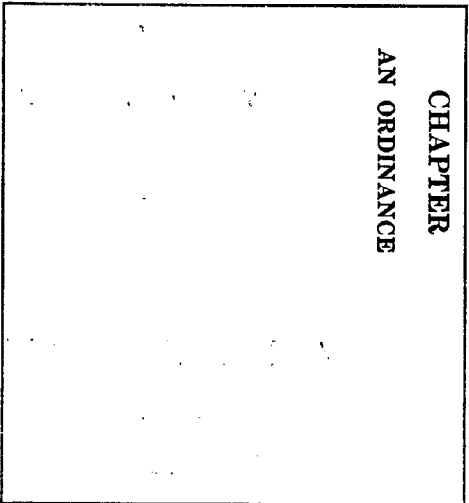

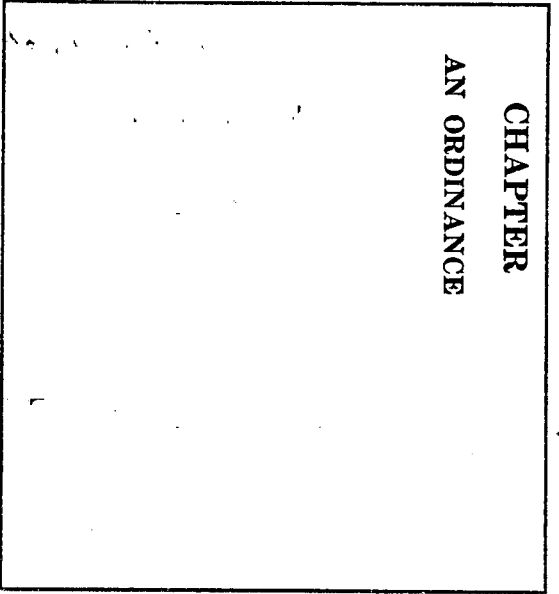

AMENDING CHAPTER 886 BY APPROPRIATING

TWO THOUSAND (\$2,000) DOLLARS TO AN ACCOUNT IN THE GENERAL FUND

TO BE KNOWN AS, "DUTCH ELM DISEASE CONTROL ACCOUNT".

Be it ordained by the City of Providence:

SECTION 1: Chapter 886 of the Ordinances of the City of Providence as approved September 17, 1954, entitled: "An Ordinance Making Appropriation of \$30,448,534.47 for the Support of the City Government for the Fiscal Year Ending September 30, 1955", as amended, is hereby further amended by appropriating the sum of Two Thousand (\$2,000) Dollars to an account in the General Fund to be known as, "DUTCH ELM DISEASE CONTROL ACCOUNT".

SECTION 2: The said sum of Two Thousand (\$2,000) Dollars herein appropriated shall be transferred to the Dutch Elm Disease Control Account in the Trust and Special Funds. Any balance remaining in the account upon completion of the Dutch Elm Disease Control program shall revert to the General Fund.

SECTION 3: The said sum of Two Thousand (\$2,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 4: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Two Thousand (\$2,000) Dollars.

SECTION 5: This Ordinance shall take effect upon its passage.

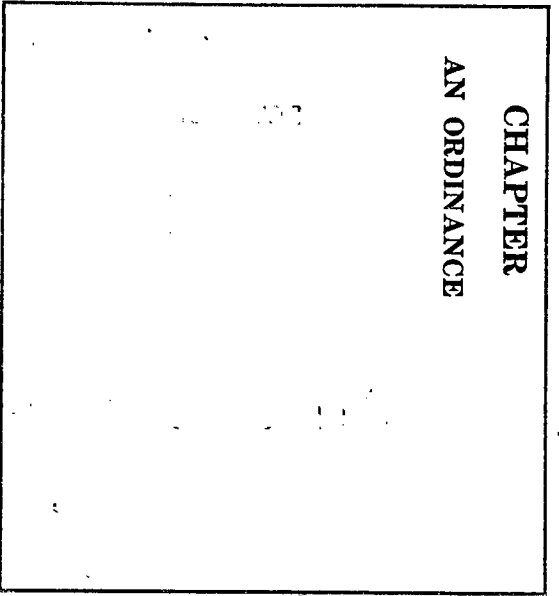
