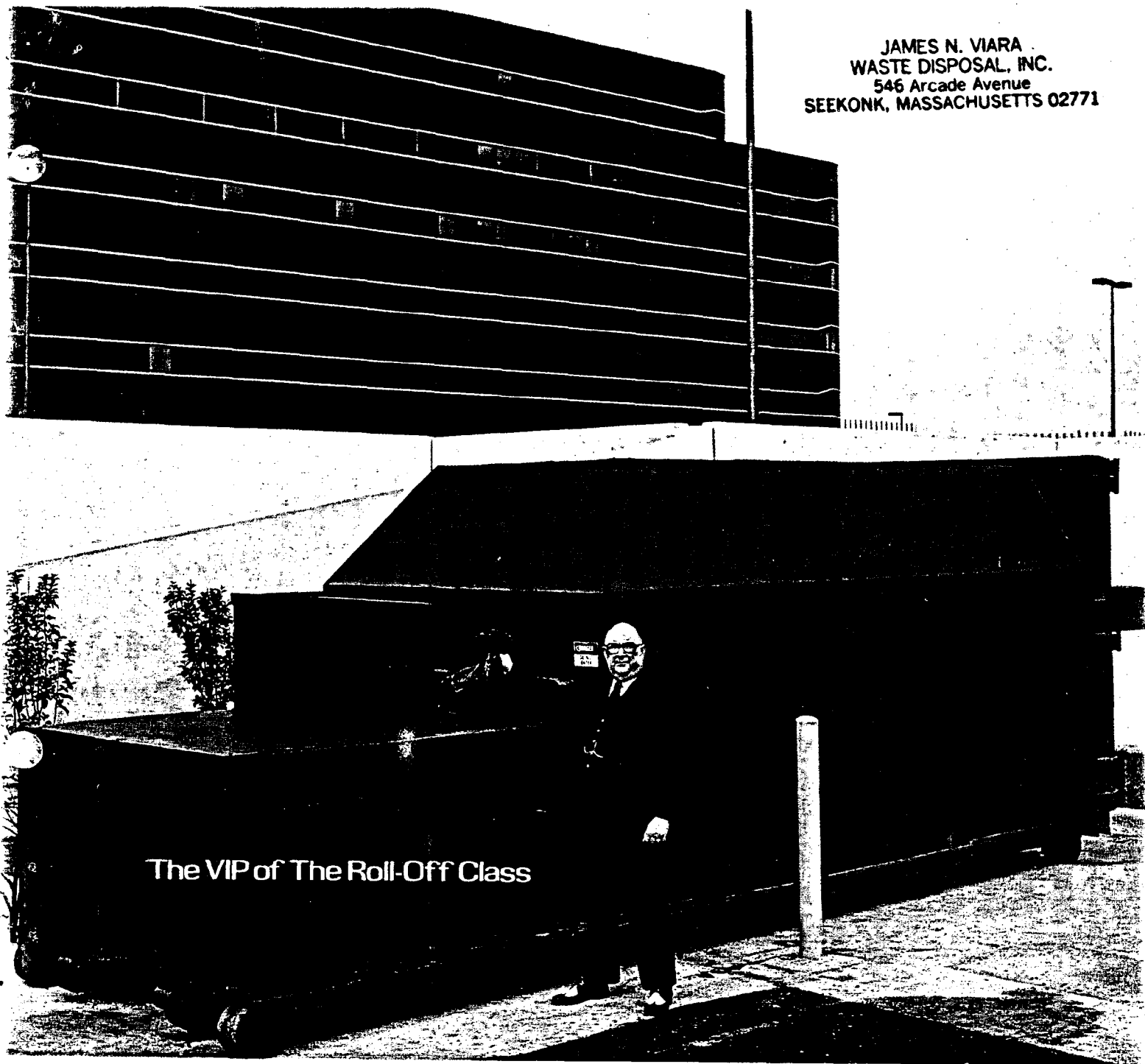

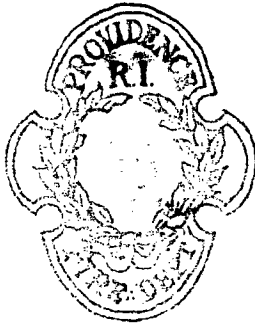



Dear Mayor Cianci:

For some time as you know, the Biltmore Plaza has been concerned with trash disposal on Eddy Street behind the Hotel. We have received several citations from the City Council addressing the situation. To date, we have spent a considerable amount of time and money in coming up with a plan that we think meets everybody's needs in solving of the trash compactor problem. Every city department has been advised and has felt that the proposed solution was feasible and workable. Letters to that affect have been forwarded to the City Council. Considerable fees and management time has been spent in developing and reviewing the plans that now sit before the Public Works Committee of the City Council. We went to the additional expense of hiring an attorney to advise us as to the proper political process.

To date, we have received no word from the City Council concerning our plans. While we continue to believe that the plans as proposed were in everyone's best interest, our best efforts (not to mention the considerable amount of money spent), have only met with frustration. Unless there is a sincere desire on the part of the Council to work with us, we will not continue our efforts. Unless we hear otherwise, we will consider the matter closed.

On May 12, the Committee on Public Works, of which I am Chairman, studied your proposal as referred to in your communication dated August 16, 1982.

The Committee at that time felt that blocking part of Eddy Street was not in the best interest of the City of Providence. Also, at that meeting the Deputy Director of Public Works stated that he had not had an opportunity to study this plan as presented before the members.

Therefore, as Chairman, I showed Mr. Lembo these plans. At that time it appeared to me that he was not satisfied with said plans.

You stated in your letter that your proposal was in the best interest of everyone. I beg to differ, Sir.

Since that time, I have not heard from Mr. Lembo. With respect to the Traffic Engineer, we know that Mr. Tibaldi approves everything, so we take Mr. Tibaldi's recommendation rather lightly.

Myself and the members of my Committee do not feel that these plans are feasible at this time. If you are so frustrated, why did it take you until August 16th to write to the Mayor, and send me a copy, as Chairman.

You talk about the political process. The political process is that I am Chairman and your request should have been submitted to me in that capacity. Had you requested an opportunity to appear before my Committee, I would have afforded you that opportunity and at the same meeting would have had the proper department heads present and given you the opportunity to present your request to all involved.
