No. 278 **AN ORDINANCE** IN AMENDMENT OF AND IN ADDITION TO ARTICLE IX OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: "TRAFFIC ENGINEERING DEPARTMENT", BY ADDING SEC. 2-160-1.

Approved May 9, 1986

Be it ordained by the City of Providence:

SECTION 1. Article IX of the Code of Ordinances of the City of Providence is hereby amended by adding thereto the following:

"Section 2-160-1. Temporary Removal of Parking Meters from Service Due to Building and Road Construction Projects, Dumpsters, Street Closing, and Special Events.

Private contractors, utility companies, and others requesting the temporary removal of parking meters from operation in the City of Providence due to building and/or road construction, dumpster placement, street closing, or special events shall pay to the City of Providence one hundred percent (100%) of the daily lost parking meter revenue. The Traffic Engineer shall determine and assess the lost parking meter revenue based upon the prevailing meter rates, the hours of daily operation, and the number of days the meters are out of service."

SECTION 2. This Ordinance shall take effect upon its Passage.



RE: Ordinance Amendment to Article IX, establishing Section 2-161 entitled "Temporary Removal of Parking Meters from Service Due to Building and Road Construction Projects, Dumpsters, Street Closings and Special Events".

FOR: Transmittal to the Providence City Council and Councilman Thomas G. Glavin, Chairman Committee on Ordinances

Regularly, the Traffic Engineering Department receives requests from construction companies and others to temporarily remove parking meters from service, that is, operation due to building and road construction projects, dumpsters, street closings or special events. The lost meter revenue is estimated at several thousand dollars per year.

I recommend an ordinance be passed to mandate that the construction firm, utility company, or party requesting the temporary removal of parking meters be required to pay the full amount of the lost meter revenue based upon the meter rates, hours of operation, and lost days of revenue. Proposed language is as follows:

BE IT ORDAINED BY THE CITY OF PROVIDENCE:

Section 1. Article IX of the Code of Ordinances of the City of Providence is hereby amended by adding thereto the following:

" Section 2-161. Temporary Removal of Parking Meters from Service Due to Building and Road Construction Projects, Dumpsters, Street Closings, and Special Events.

Private contractors, utility companies, and others requesting the temporary removal of parking meters from operation in the City of Providence due to building and/or road construction, dumpster placement, street closing, or special events shall pay to the City of Providence one hundred percent (100%) of the daily lost parking meter revenue. The Traffic Engineer shall determine and assess the lost parking meter revenue based upon the prevailing meter rates, the hours of daily operation, and the number of days the meters are out of service.™

Section 2. This Ordinance shall take effect upon its Passage.
