

NOW, THEREFORE, BE IT RESOLVED, That the taxes, in the amount of \$388.16 (three-hundred and eighty-eight dollars and sixteen cents), assessed for year 2014. Assessors Plat: 107 Lot: 353, (56 Heath Street) a 2,500 sq. ft. parcel vacant lot, in the City of Providence along with any associated interest, penalties and intervening taxes are hereby abated in whole and that the property is declared exempt in accordance with Rhode Island General Law 45-32-40 while under PRA ownership.


