As discussed, on January 14, 2009 I requested that Sam Guedouar, then currently a board member of the PWCVB, be replaced with Robert Cartwright. Mr. Guedouar was moved into the position of Regional Manager and Mr. Cartwright was to replace him at The Westin Providence as General Manager.
