"An Act Relating to Education".



RELATING TO EDUCATION

Introduced By: Senators Ruggeiro, Cruise and McBurney

Date Introduced: January 8, 1987

Referred To: Senate H.E.W.

It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 16-19 of the General Laws entitled, "Compul-
2 sory Attendance" is hereby amended by adding thereto the following
3 section:

4 16-19-10. Pupil absence notification program. -- The school com-
5 mittee of each city, town or regional school district or the director
6 or other person in charge of private schools of elementary and high
7 school grades shall cause all schools under their control to establish
8 pupil absence notification program. The parents or guardians of each
9 pupil shall annually at the commencement of the school year, be sent a
10 notice instructing them to call a designated telephone number at a
11 designated time to inform the school of the absence of a pupil and the
12 reason therefor. Said notice shall also require said parents or
13 guardian to furnish the school with a home, work or other emergency
14 telephone number where they can be contacted during the school day. If
15 a pupil is absent and the school has not been notified by the desig-
16 nated time the school shall call the telephone number or numbers fur-
17 nished to inquire about said absence.
