RESOLVED,

That in accordance with the provisions of Section 28, Chapter 1665 of the Public Laws of 1945, approved April 27, 1945, the City Controller is hereby authorized and directed to establish in the accounts for the year ending June 30, 1970, a specific purpose account to be known as "Reserve for Revenue for Extraordinary Expenditures of the year 1970-1971". Said Account shall be established by charging to the account entitled "Current Year Surplus" of the accounts of 1969-1970, an amount equal to any credit balance existing in said Current Year surplus account at the close of the fiscal year. After completion of the above transfer, any balance existing in the account entitled "Reserve for Revenue for Extraordinary Expenditures of the Year 1970-1971" shall be carried over to the books of account for the year 1970-1971.

From time to time during the period ending June 30, 1971, the City Council, when necessary, may direct the City Controller and the City Treasurer to pay out of General Fund Cash the total or any part of the then credit balance existing in the account entitled "Reserve for Revenue for Extraordinary Expenditures of the Year 1970-1971" each such payment shall be charged to said account and shall immediately be paid over to the City Collector as a receipt account, and when so received by him shall be credited to a receipt account to be entitled "Receipts for Extraordinary Expenditures of the year 1970-1971".

WHEREAS, Joseph C. Keegan, Finance Director has elected to retire on June 30, 1970 thus terminating services with his native City of Providence, which started on August 20th, 1943 as First Deputy City Auditor; City Auditor from January 2, 1945; City Controller from June 14, 1945 and Finance Director from February 7, 1964, until his retirement scheduled for June 30, 1970, and

WHEREAS, during the one quarter century plus that "Joe" Keegan served the financial section of City government, he was responsible for inaugurating the Data Processing Program which included Appropriation Accounting and Funds control of Employees Retirement System, in lieu of bookkeeping machines; the updating of wages and vital payroll information for employees on a year to day basis, and

WHEREAS, the distinguished career Finance Director was responsible for the Management of the several Divisions within the Finance Department which employed approximately one hundred employees, being the largest administrative staff in City government, and

WHEREAS in the service of the City, Mr. Keegan's devotion to fiscal problems and related problems were never governed by the time of day and it was not unusual for him to be at his desk on weekends and holidays.

NOW THEREFORE BE IT RESOLVED, That with the forthcoming retirement of Joseph C. Keegan, Finance Director, His Honor Mayor Joseph A. Doorley, Jr., joins the Members of the City Council and the employees of the City in expressing their genuine feeling of deep gratitude for the unstinting service he rendered to the Municipality and its Citizenry and wish that he enjoy many years of a well earned retirement.

RESOLVED, That this Minute on the Life and Character of Edward P. Quigley, late Member of the City Council who died June 16th, 1970, be and the same is adopted and ordered inscribed on the Records of the City Council.

MINUTE

Edward P. Quigley was elected to the City Council from the Eleventh Ward as a Democrat and served from January 6, 1941 to January 4, 1965.

During his tenure as a Member of the City Council, his colleagues elected him as Council President for two successive terms from January 5, 1959 through January 7, 1963.

He was also a Member of the Appeal Board of the Air Pollution Regulation for almost ten years, during the period of October 16, 1947 to March 31, 1957.

"Ed" Quigley a native of the City of Providence who was born on November 22, 1888, endeared himself to everyone with whom he communicated. His record of Fraternal, Religious, Social and Civic activities afforded him a wide scope of accomplishments and acquaintances.

A devote member of the Roman Catholic Faith, he served his Church and the Knights of Columbus in every capacity "through the Chairs" and was honored by that organization many times for unselfish devotion to its principals.

The rhetoric of "Ed" Quigley was legendary, his whimical cliches emanating from a warm Irish personality, were often cited as masterpieces.

Mr. Quigley was a adherent and loyal worker for the Democratic Party whose allegiance personified his principals.

His interest in sports brought much pleasure to the Citizens of our community for he reactivated many sports activities as the indefagiable Chairman of the City's Celebration of Columbus Day for almost one quarter of a century.

All who knew him truly called him "One of God's Noblemen".

NOW THEREFORE BE IT RESOLVED, that in noting the passing of Edward P. Quigley, late Member of the City Council, His Honor Mayor Joseph A. Doorley, Jr., and the Members of the City Council pause and bow their heads in silent prayer in respect to the memory of he who so graced the Chamber of the City Council with his presence and further pray that Almighty God, in His Devine Wisdom, bestow eternal peace onto his Soul.
