
Dear Madame Clerk:

In accordance with Section 21-26 of the City's Code of Ordinances, I am writing to request that the following requested contract awards be submitted to the City Council and the Ways & Means Committee for approval.

- *Water Supply Board* – Award of Architectural – Engineering Services (Blank 2013-2016) in an amount of \$10 million over a three year period.
- *Water Supply Board* – Renewal of an existing cooperative program with the United States Geological Survey – a sole source – to monitor water quality within the Scituate Reservoir Watershed in an amount not to exceed \$300,000 per year.
- *Water Supply Board* – Sole source award to Pure Technologies to provide real time monitoring services on a continuous 24 hour per day basis of a fiber optic data acquisition system and acoustic monitoring sensor line in amount not to exceed \$110,000 per year.
- *Water Supply Board* – Sole source blanket award with Hach Company to engage in preventative maintenance services in a an amount not to exceed \$20,000.

These services will be utilized to provide engineering services on an as-needed basis to support Providence Water's staff in areas requiring specific expertise and engineering disciplines and to facilitate progress on a wide range of capital improvement and infrastructure replacement projects. Examples of such projects are listed below:

- Distribution system rehabilitation, including water main replacement/cleaning and lining
- GIS enhancements
- Water quality work, including piloting work, expert panel related studies and sedimentation basin rehabilitation
- Transmission main inspection and rehabilitation, including 78", 90" and 102" aqueducts
- Chemical storage, transfer and feed systems upgrades

In addition to the anticipated projects mentioned above, these engineering services will be utilized for any other unforeseen project(s) that may arise.

A scope of work will be developed for each individual project. Competitive prices will be solicited from multiple firms as appropriate. In the event that these services are required on an emergency basis, it still affords Providence Water with the opportunity to receive competitive pricing. The individual projects will be invoiced at the prices and hourly rates provided by the successful proposers in their proposals. Similar to the previous engineering services contracts, a single joint award, in an amount not to exceed \$10,000,000 for a three year period ending December 31, 2016, will be made which can be cumulatively utilized as appropriately needed among the successful proposers.
