\* These positions are eligible for an additional \$.50 per hour once the NEWWA Water Distribution System, Senior Water Treatment Operator and Water Treatment Operator III Certificates have been obtained.

Section 2. The salary for each position is categorized as one (1) of seventy-six (76) "Pay Grades", each of which contains five(5) "Steps", or, the rate listed in Section 1 above. The "Pay Grades" and "Steps" are enumerated and set forth in Section 7(Grade 1-35) and Section 8 (Grades M1-M41).

Section 3. The above paygrades and rates do not include additional compensation for employees who may be requested to work a non-standard work week, have met the CDL requirements as per the Bargaining Unit Agreement, or have obtained a RI Dept. of Health D-1 in Training Certificate.

Section 4. The above pay grades do not include additional compensation for Supervisors who are eligible and may receive on-call pay.

Section 5. Effective with the adoption of this Ordinance, Officers, and Employees of the City of Providence may authorize Employees to perform duties of a higher rated classification, cause by leave or retirement, and that said position is funded and provided for in this Ordinance. Said assignment may be performed for a maximum of 90 days per fiscal year. Any and all other assignments of out of rank nature must be approved by the City Council following petition by the Personnel Director.

Section 6. This Ordinance shall take effect upon its passage.

An Ordinance Amending Article XII of Chapter 21 of the Providence Code of Ordinances, Entitled: "Tax Exemption for certain property owned by the Providence Redevelopment Agency".

WHEREAS, The Providence Redevelopment Agency, hereinafter the "Agency" is a Redevelopment Agency created pursuant to Chapters 31-33 of Title 45 of the Rhode Island General Laws, the "Redevelopment Act of 1956", and is charged with redevelopment on behalf of the City of Providence; and

WHEREAS, The Providence City Council, pursuant to its authority under Rhode Island General Laws § 45-32-40 and in accordance with the laws of the State of Rhode Island and the Code of Ordinances for the City of Providence, has the exclusive authority to exempt real property owned by the Agency; and

WHEREAS, It is in the interest of the residents of the City of Providence for the municipal government to operate in the most effective and financially-prudent manner, the Providence City Council hereby amends the Providence Code of Ordinances as provided herein.

**NOW, THEREFORE, Be It Ordained by the City of Providence:**

Section 1. That the findings set forth in the preceding recitals are hereby made and confirmed.

Section 2. Definitions. All capitalized terms not otherwise defined herein shall have the meanings set forth in Chapters 31-33 of Title 45 of the Rhode Island General Laws, the City of Providence Home Rule Charter of 1980, and the Providence Code of Ordinances, as amended.

Section 3. Amendment of Article XII of Chapter 21 of the Providence Code of Ordinances. The City of Providence, in accordance with the laws of the State of Rhode Island and the Providence Code of Ordinances, is hereby authorized to amend Article XII of Chapter 21 of the Providence Code of Ordinances, entitled "Tax Exemption for Certain Property Owned by the Providence Redevelopment Agency", as provided herein, and does hereby amend by deleting Article XII of Chapter 21 in its entirety and consent to the amendment by inserting the following:

Article XII. - Tax Exemption for Certain Property Owned by the Providence  
Redevelopment Agency

Sec. 21-211. - Tax-exempt property acquired for the development of the MET School and  
the development of the public safety facility.

The following real property shall be exempt from taxation, pursuant to R.I. Gen. Laws,  
Section 45-32-40, as amended:

- (a) Certain real property acquired and owned by the Providence Redevelopment  
Agency which has been acquired for the development of the MET School; those

Sec. 21-212. - Generally - Tax exempt property.

- (a) In addition to Section 21-211 above, and subject to the exceptions found in Sub-  
section (b) below, all real property owned by the Providence Redevelopment  
Agency shall be exempt from taxation throughout the entire period of ownership,  
pursuant to R.I. Gen. Laws Section 45-32-40, as amended.
- (b) Notwithstanding Sub-section (a) above, the exemption from real property taxation  
shall apply under the following conditions:
  - i. the exemption shall not operate to abate, cancel, or remove taxes already due  
and owing on any given real property prior to the Providence Redevelopment  
Agency's acquisition and ownership;

- ii. the exemption shall not operate to make the real property acquired and owned by the Providence Redevelopment Agency tax exempt at any point in time after the Providence Redevelopment Agency disposes of the property. Regardless of the Agency's ownership of any given property on the date of assessment prior to its disposition of the property, said property will become taxable based on that prior assessment value and the remaining apportionment of taxes shall be due and owing from the individual or entity who receives the disposition of that property from the Agency from the date of transfer. The Agency shall notify the Tax Assessor and Tax Collector of said disposition to ensure corrected tax bills are sent to the new owner; and
  
- iii. the Providence Redevelopment Agency may elect to disregard its exemption status and declare certain property taxable by notice to the Tax Assessor and Tax Collector in order to effectuate the redevelopment of said property which it may acquire and own from time to time.

Section 4. Miscellaneous. Except as specifically provided herein, the provisions of Article XII of Chapter 21 of the Providence Code of Ordinances shall remain unchanged and in full force.

Section 7. Effective Date. This Ordinance shall become effective immediately upon its passage by the City Council and approval by the Mayor.

"Very quickly, just an update on what's going on with the Finance Committee. As you know, a couple of months ago the Finance Committee requested to administration to give us an update on the original \$45 million dollar bond. What you have before you is a binder reporting said bond. They came in at the last couple of finance meetings and they put together this booklet. It's a cover sheet from me to you explaining it. As they update the book I will then make sure you all get the updates accordingly. If you have any questions, of course its in the book. Gina knows a lot about what's going on too. Basically, it's an accounting of that bond initiative. If you look through you will see that some items have been done, some items aren't done, some items are in the middle of being done. So, take a look, questions, concerns, ask Gina and then of course I always invite all my colleagues to come to the finance committee meetings when they bring the Director of Public Property to come back and to explain and give updates. So, please come, participate, a lot of you do. It's very informative and I think council members, committee members and the public had an opportunity to get on the stand. The main reason is because we want to get a sense of where we are with the first \$45 million dollar bond and at the same time the administration is also requesting for another \$77 million dollar bond. We just want to make sure this is being done accordingly. Director Borg did identify several lessons he's felt that he learned in the process that now he is going to apply for the upcoming one. For example, doing some scoping beforehand, trying to get a 20% or 30% design plan at the beginning so we have a better understanding of a project instead of saying well we think it's going to be a million dollars and the project may come in less or more they will actually have a 20% or 30% design plan and that will give you a better value point so this way we can truly monitor the amount of money and what it's going to cost. This way when they come in front of all of you and all of us, when they say these are the projects, these are the price points you will have a better understanding and handle on what it's going to cost let's say to build a park, or a playground or recreation center. So, that's one of the lessons he learned and he said they are going to implement that procedure. So, take a look at it, review it and if you have any other questions please don't hesitate to call me. I will more than happy to answer questions after a meeting or Gina has even more information. Thank you for your time."
