Burchard Street, shown as cross-hatched area on the accompanying plan and designated by the letters (A-B-C-D-A), having ceased to be useful to the public and the same is proposed to be abandoned as a Public Highway; and the damage to the abutters is appraised at nothing and so awarded, and it is further


ORDERED, That the Traffic Engineer, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further


ORDERED, That after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

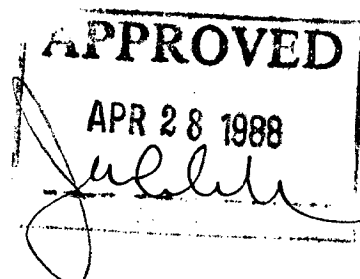

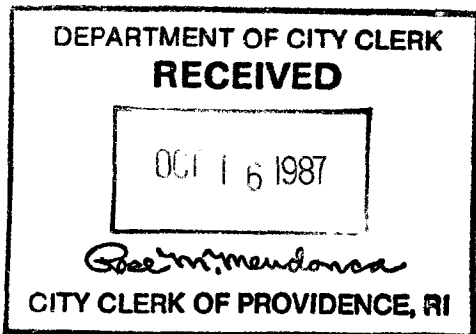
PETITION TO THE CITY COUNCIL

Gentlemen:

The City Plan Commission at its December 16, 1987 regular monthly meeting, reviewed and evaluated the subject referral from your Committee on the proposed abandonment of a portion of Burchard St. located between Petteys Ave. and Dedham Ave.

The petitioner is J. A. Baccala & Sons, Inc. of 100 Armento St., Johnston, RI, owner of adjacent Lots 298 and 335 on Assessor's Plat 112. The petitioner is represented by Paul V. Jabour, Esq., of 339 Angell St., Providence, RI.

A field inspection revealed that the subject street is a paper street and that all land surrounding it is vacant.

This vacant land overgrown with weeds and brush is a former ash and can landfill, where necessary expensive excavation, fill and footing make the construction of single family homes prohibitive.

The area is currently zoned R-1 and the petitioner together with the developer have filed an application for a variance to the Zoning Board of Review.

The petitioner is planning to construct 48 townhouses two (2) stories in height in the form of condominiums on aforesaid lots and the proposed abandonment is necessary to facilitate the development.


Dedham Ave. is a dead-end street; the paved portion ends on the northern boundary of Lot 343 and the paper portion ends on the southern boundary of Lot 321. Therefore, it is advisable to connect this street to Petteys Ave. either along the existing legal right-of-way of Burchard St. or preferably along the northern boundary of Lot 343.
