SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, and entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by adding the sum of Sixty Five Thousand (\$65,000) Dollars to the appropriation contained therein for CHAPIN HOSPITAL, ITEMS 0, 1 and 2. Said sum of Sixty Five Thousand (\$65,000) Dollars shall be apportioned as follows: ITEM 0 - \$25,000; ITEM 1 - \$30,000; ITEM 2 - \$10,000.

SECTION 2: The said sum of Sixty Five Thousand (\$65,000) Dollars as thus added and appropriated shall be obtained by increasing the estimated receipts as follows:

SECTION 1: Chapter 987 of the Ordinances of the City of Providence as approved September 16, 1955, entitled: "An Ordinance Making Appropriation of \$31,832,600.04 for the Support of the City Government for the Fiscal Year Ending September 30, 1956", as amended, is hereby further amended by adding the sum of Seventy Five Hundred (\$7500) Dollars to the appropriation contained therein for PROVIDENCE REDEVELOPMENT AGENCY. Said sum of Seventy Five Hundred (\$7500) Dollars shall be apportioned as follows: ITEM 0 - \$6,700; ITEM 1 - \$400.00; ITEM 2 - \$400.00.

SECTION 2: The said sum of Seventy Five Hundred (\$7500) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures are hereby increased by Seventy Five Hundred (\$7500) Dollars.





AN ACT

IN AMENDMENT OF CLAUSE 3, OF SECTION XII OF CHAPTER 598 OF THE PUBLIC LAWS, 1866, AS AMENDED AND CONTINUED, RELATING TO THE POLICE COURT OF THE CITY OF PROVIDENCE.

It is enacted by the General Assembly as follows:

SECTION 1. Clause 3 of Section XII of Chapter 598 of the Public Laws, passed at the January Session, A.D. 1866, entitled "An Act to Revise, Consolidate and Amend the Act Entitled 'An Act to Incorporate the City of Providence' and the Several Acts in Addition Thereto and in Amendment Thereof", as amended by Chapter 1446 of the 1929 Public Laws, and as continued in force and effect by Section 134 of Chapter 832 of the Public Laws, 1940, known as the "Providence Charter Act of 1940", is hereby further amended to read as follows:

"Clause 3 (a). Said court shall have original jurisdiction of all offenses against the act entitled 'An Act to Authorize the City of Providence to Establish a House of Correction, and for other Purposes', and all acts in amendment thereof, and of all offenses against the ordinances, by-laws, rules and regulations of the City of Providence and of its City Council, where the fine, penalty, pecuniary forfeiture, forfeiture of personal property, punishment or imprisonment for any one offense shall not exceed two hundred (\$200) dollars and six (6) months' imprisonment, or two hundred (\$200) dollars in value. Said court shall also have exclusive jurisdiction and cognizance of all offenses and misdemeanors done or committed within the City of Providence which involve a violation of any statute, rule or regulation governing the use and operation of motor vehicles on the public highways punishable by a fine not exceeding \$500 or by imprisonment not exceeding one (1) year, except those offenses specifically excluded in Clause 3 (b). The proceedings in all cases in said court, except as otherwise provided, shall be commenced by complaint and warrant; and all said fines, penalties, pecuniary forfeitures, forfeitures of personal property, punishments and imprisonments may be prosecuted for, recovered, and imposed on complaint and warrant before said court, and on appeal therefrom before any proper court in any appellate proceedings."

"Clause 3 (b). Said court shall not have jurisdiction and cognizance of the following offenses:

- (1) Violations of the licensing or registration laws of the State of Rhode Island;
- (2) Violations of Article III of the Motor Vehicle Code Act of Rhode Island, Chapter 2595 of the Public Laws, 1950, and amendments thereto; Title 3, Ch. 9
- (3) Violations of Article XXIII of the Motor Vehicle Code Act of Rhode Island, Chapter 2595 of the Public Laws, 1950, and amendments thereto; 26
- (4) Violations of Article XXIV of the Motor Vehicle Code Act of Rhode Island, Chapter 2595 of the Public Laws, 1950, and amendments thereto; 27
- (5) Violations of Section 79 of Chapter 608 of the General Laws of Rhode Island, 1938. 11-41-17

SEC. 2. This Act shall take effect upon its passage. Any act or acts inconsistent with the provisions of the second sentence of Clause 3 (a), as herein set forth, shall be deemed inapplicable to the City of Providence.
