RESOLUTION OF THE CITY COUNCIL

No. 188

Approved March 13, 1986

WHEREAS, The Federal Government seems to be eliminating the Urban Development Action Grants (UDAGS), and

WHEREAS, The UDAGS have been responsible for the building of the Arcade Garage, Davol Square and the restoration of the Biltmore Hotel, and

WHEREAS, UDAG'S generate \$6 of private investment for every public \$1 invested and have created 528,000 jobs nationally and often make the difference between growth and stagnation for many cities, and

WHEREAS, UDAG'S are essential to the development of the Outlet Building, Shepards and other under utilized Providence property, and

WHEREAS, The State of Rhode Island has a billion dollar budget and a surplus of \$42 million,

NOW, THEREFORE, BE IT RESOLVED, That the State create a UDAG program if the Federal Government eliminates the existing UDAG program.
