



ANNUAL REPORT OF THE ACTIVITIES OF THE ZONING BOARD OF REVIEW  
AND THE ZONING OFFICE FOR THE CALENDAR YEAR 1970

During the year 1970, the Zoning Board of Review held twelve public hearings on applications for exceptions or variances and a corresponding number of executive sessions. For the year 1970, the Board acted on 86 applications of which 70 were granted, 9 were denied and 6 requested leave to withdraw. One extension was requested and was granted. The Board heard one case which was an appeal from the Director of the Department of Building Inspection's decision, on the definition of a family as defined by the Zoning Ordinance. The Board upheld the Director's decision.

The Superior Court of the State of Rhode Island denied and dismissed the plaintiff's appeal in one case, thus upholding the Zoning Board. There are currently two decisions of the Board pending appeal before the Superior Court of the State of Rhode Island.

The following Board activity took place: Mayor Joseph A. Doorley, Jr., reappointed Frank A. DelSesto, May 15, 1970, for a term ending the first Monday in June, 1975; reappointed James G. Dolan, May 15, 1970, for a term ending in June, 1971; and, reappointed Frank A. DelSesto as Chairman.

On March 23, 1970, the Providence City Council amended the Zoning Ordinance to provide a filing fee of twenty-five dollars (\$25.00) for any appeal, special exception or variance.

ANNUAL REPORT OF THE ACTIVITIES  
THE BUILDING BOARD OF REVIEW  
THE CALENDAR YEAR 1970

For the year 1970, the Building Board of Review held 14 meetings. At 10 of these meetings, regular applications for variances or modifications were heard. Filings under Chapter 1643 were heard at 1 of these meetings, and 4 meetings were exclusively devoted to filings under Chapter 1643.

Of the 29 regular applications for variances or modifications of the Building Ordinance, 8 of these petitions were granted as filed, 18 granted with provisions, 2 were denied, and 1 was continued pending further consideration by the Board.

Of the meetings dealing with Chapter 1643, there were 66 filings by the Director of the Department of Building Inspection resulting in 57 resolutions. A comprehensive breakdown follows:

The Board read and adopted new rules and regulations for the Building Board of Review on December 16, 1970 to comply with the amendments and changes contained in Chapter 69-27 an Ordinance in Amendment of the Building Code, Chapter 1079, amending Sections 124.3, 124.5, 124.6, and 124.7. Cases formerly heard under Chapter 1643 are now treated as appeals from Decision of The Inspector of Buildings under Chapter 69-27.







The Bureau has authorized the issuance of 8,708 licenses of various types.


It has held approximately 156 informal hearings. In addition, the Bureau conducted 101 informal hearings, to which licenses were summoned by the Bureau for violations of various kinds-violations of the State Statutes, Ordinances of the City of Providence, or Rules and Regulations of the Bureau of Licenses. Many were continued from the original hearing date due to incomplete records presented, and etc.

At these formal hearings, witnesses were summoned-Police and other interested parties. In approximately 50% of the violations that were heard, licensees were represented by Counsel. An assistant City Solicitor represented the Police Department. Witnesses were sworn testimony taken, both direct and cross examination, and thereafter the members of the Bureau discussed the cases in executive session, after which they announced their decision.

For various reasons, cases were continued from time to time at the request of counsel, illness of licensee or interested parties, but usually--and this was a strict rule of the Bureau, licensees and applicants for licenses whose applications were turned down, were given prompt hearings.

In addition to the above, the Bureau also has been attending previews of motion pictures after regular hearings and on mornings, other than regular hearing days, totalling 65 days; The Bureau on several occasions previewed double features, in the interest of determining questionable obscenity, interpretation of the law and ordinances, etc. The Bureau on several occasions has ordered the City Solicitor to seek judicial review in the Courts.
