WHEREAS, Council President Rachel M. Miller, pursuant to Section 406 of the Providence Home Rule Charter of 1980, as amended and Rule 3 of the Rules of the City Council, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Monday, July 14, 2025 at 6:00 o'clock P.M., in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

An Ordinance Providing for the Assessment and Collection of 2025 Taxes in a sum not less than Three Hundred Ninety-Six Million Two Hundred Eleven Thousand Forty Four Dollars (\$396,211,044) and not more than Four Hundred Nineteen Million Eight Hundred Seventy-Eight Thousand Fifty-One Dollars (\$419,878,051), being One Hundred Percent (100%) of the 2024-2025 Fiscal Year Tax Collections, Amending Section 21-182 of the Code of Ordinances to set the rates for Fiscal Year 2025-2026, and Amending Section 21-126 of the Code of Ordinances to set the Exemptions for Fiscal Year 2025-2026.

An Ordinance in Amendment of Chapter 2024-36, No. 321, Approved June 28, 2024 of the Ordinances of the City of Providence, making an Appropriation of Five Hundred Ninety-Nine Million Seven Hundred Seventy-One Thousand Eight Hundred Seventy-Six Dollars and No Cents (\$599,771,876), for the Fiscal Year Ending June 30, 2025.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 2024-37, No. 322, Approved June 28, 2024, As Amended.


