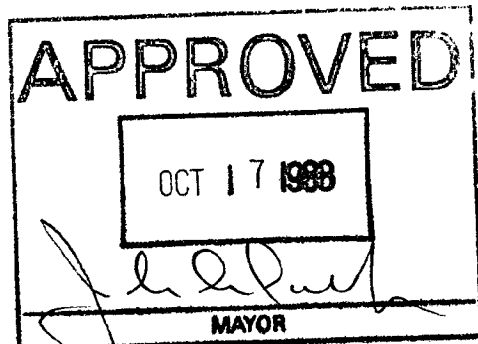
Approved October 17, 1988

RESOLVED, That the City of Providence, by and through its Mayor, Joseph R. Paolino, Jr., is hereby authorized to purchase a certain parcel of land, together with any and all improvements thereon, designated as 7-25 and 27-43 Cadillac Drive, also known as Lots 190, 191 and 192 of Assessor's Plat 60, Said parcel, being more or less 154,923 square feet, is to be purchased for a sum not to exceed \$525,000 under such other terms as may be approved by His Honor the Mayor and the City Solicitor. Said parcel is to be dedicated as a public park, or any and all related uses by the Board of Park Commissioners.

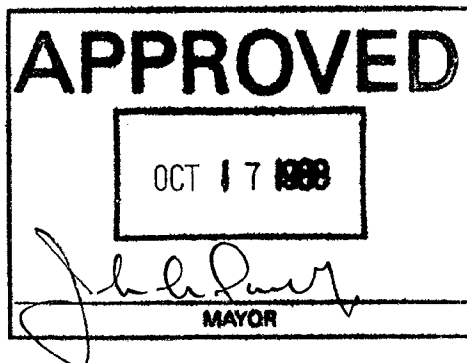

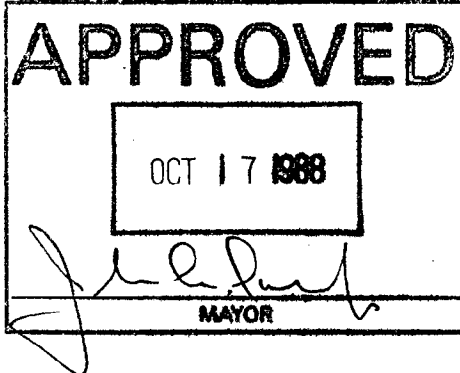

Dear Ms. Mendonca:

I have received City Council Resolution No. 506 requesting that a portion of the median strip along Elmwood Avenue, opposite the Stratford House apartments, be removed.

I regret that this is not a project that can be performed by the Department of Transportation. We do not have the equipment or the appropriate staff to handle such alterations.

However, I would like to note that a Joint Resolution, S-378, has been introduced by Senator Patterson to appropriate \$500,000 to the Department of Transportation for improvements to Elmwood Avenue in Providence from Trinity Square to the Providence/Cranston line. The department presented testimony before the Senate Finance Committee on this bill and indicated that the monies were insufficient to perform the entire project. The committee was informed that a realistic estimate for such improvements would be approximately \$1.5 million per mile or a total of \$3 million for this two-mile stretch of road.

If this joint resolution should pass the legislature with sufficient funds for the project, your request could then be considered within the context of the larger project. Any improvements of course would have to be reviewed to ensure that all design and safety requirements have been met.
