Resolution approving the accompanying plat, entitled Dedication of Knowles Walkway, Mount Hope Renewal Project R. I., <sup>B-18</sup> ~~R-8~~, Providence Redevelopment Agency, Stanley P. Blacher, Chairman, et al, Scale 1"=80.0' dedicating for walkway purposes certain tracts or parcels of land, shown as a cross-hatched area and designated by the letters L-M-N-K and B-C-D-E-F-G-B and altering the shaded areas designated by the letters M-A-H-J-N from highway purpose to walkway purpose on the accompanying plan under the provisions of Chapter 987 of the Public Laws of 1913 and thereafter declared a public walkway to be repaired and maintained at the expense of the City of Providence.






Dear Mr. Vespia:
