


Dear Councilman Flynn:

Subject: Conversion of Portion of DePasquale Avenue to a Pedestrian Plaza

Gentlemen:

The City Plan Commission at its March 19, 1979 regular monthly meeting evaluated the subject petition to convert that portion of DePasquale Avenue from the southerly line of Spruce Street to the northerly line of Atwells Avenue to a Pedestrian Plaza. The length of that portion of DePasquale Avenue in question is approximately 202 feet and has a width of 70 feet.


A field inspection revealed that the portion of DePasquale Avenue in question is under construction as a pedestrian plaza by Cardi Corp. of Warwick. It is part of the redevelopment plan of the Federal Hill East Renewal Project to revitalize the Atwells Avenue area of Italian shops and restaurants. The \$ 3-1/2 million plan calls for major street and sidewalk improvements on Atwells Avenue from Route 95 to the Holy Ghost Church at Knight Street. The concrete sidewalks will be replaced with decorative masonry materials and elegant old style street-lights. It calls for an arched gateway to the Hill near the highway, new squares in front of the Avenue's three churches and a most dramatic improvement will be to convert the aforesaid portion of DePasquale Avenue into an auto-free zone for an outdoor market. Several markets already face on DePasquale Plaza. A new fountain and covered stalls will be added on the plaza to attract more vendors and shoppers. Therefore,


Dear Councilman Flynn:

Regarding subject, it has been brought to our attention by Mr. Stanley Bernstein, Director of the Providence Redevelopment Agency, that DePasquale Avenue, between Atwells Avenue and Spruce Street, will remain a public right-of-way. Consequently the 6-inch C.I. water main that we referred to in our March 7, 1979 correspondence can remain in service along with the supplies to houses #61 and 64.
