
Senator Stephen Fortunato addressed the hearing and stated that he was in favor of having the building converted to an administration building for the Providence School Department and stated further, that it was his feeling that the housing of Providence School Department employees in the Federal Hill area would be extremely advantageous to the vendors and merchants in the area. Councilman Anthony Pennine, Theresa Ferrandi, Leo DeRouine, Marie Fraielli, Tina Regan, Steve Constantino, Filomena Lupo, Allen Silva, Geraldine Prate and Joseph Fratus were also in favor of having the building as an administration center.

Those who opposed the administration building were as follows: Councilman Joseph Paolino, Jr., Carolyn Berarducci, Mary Romeo, John Orabona, Raymond Mancini, Richard Tarro and Tosca Casinelli.

Following the remarks of the many individuals present, Councilman Paolino then agreed that perhaps it would be a good idea to retain the building. However, he did request that areas of green and trees surround the building in order to enhance the area and make it more desirable to those tenants immediately surrounding it. This recommendation was acceptable to certain opponents present.
