

Honorable Members of the City Council

Gentlemen:

In accordance with your Resolution requesting the Commissioner of Public Safety to Examine the Pay Status of the Police School Crossing Guards with a View towards affording a Permanent Pay Status, I have examined this matter and herewith respectfully report my findings:

First, I do not feel that any permanent pay status other than the one now in effect, is necessary.

Second, inasmuch as all schools operate on a 180 school day year, their pay for a complete cycle of school days annually, shows little or no variation. The trivial exceptions where the closing of private schools may work as a disadvantage to a few guards for a few hours, can be eliminated in the future by seeing to it that on those particular days the crossing guards affected, are assigned to other locations.

I do, however, recommend and deem it advisable to include as payable holidays February 22, May 30 and November 11 as an additional increment in the Traffic Guards annual salary, if the same meets with the approval of your Honorable Body.
