AN ORDINANCE IN AMENDMENT OF AND IN ADDITION TO ARTICLE 1 OF CHAPTER 17 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: "OFFICERS AND EMPLOYEES, AS AMENDED."

Approved May 24, 1984

Be it ordained by the City of Providence:

SECTION 1. Chapter 17 of the Code of Ordinances of the City of Providence entitled "Officers and Employees" is hereby amended by adding to Article 1 thereof the following:

Section 17-29. Statements of Other Employment.

(a) Each existing employee of the City of Providence shall, within 30 days after the effective date of this ordinance and each person hereafter entering into employment with the City of Providence shall, at the time of commencing employment with the City of Providence, execute and deliver to the Personnel Director of the City of Providence a certified statement setting forth the following information:

1. Whether the employee has any employment other than his or her employment with the City of Providence.

2. If so, the name and address of the other employer, the nature of such employment and the number of hours and times per week spent on such other employment.

3. Whether the employee has any other source of income which is payable on account of said employee's performance of services other than services performed as an employee of the City of Providence.

4. If so, the identification (including name and address) of the source of such income, the nature of the services performed and the number of hours and times each week during which such services must be performed.

(b) Any employee of the City of Providence shall, within 15 days after any change in circumstances which renders said employee's existing statement under Section 17-29(a) incorrect or incomplete in any respect, file an amended form setting forth the correct and complete information.

(c) Any employee who fails to file and maintain on file an accurate statement required by Section 17-29(a) and (b), shall be subject to disciplinary action including, without limitation, termination of employment and all benefits associated therewith and shall be guilty of an offense under this Code of Ordinances, punishable as set forth in Section 1-10 of this Code of Ordinances.

(d) The Personnel Director of the City of Providence shall, upon the effective date of this ordinance, prepare a form of statement consistent herewith, shall thereupon and from time to time thereafter provide such statement to each existing and new employee of the City of Providence and shall maintain all such statements on file. All such statements shall be public records of the City of Providence.

(e) No employee shall be adversely affected in the terms and conditions of his or her employment solely on account of filing or maintaining an accurate certified statement under Section 17-29(a) and (b), above.

SECTION 2. This ordinance shall take effect upon its passage.

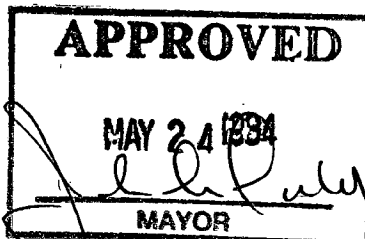


