PERSONAL EXPRESSION

COUNCILMAN CLARKIN requests the privilege of the floor to speak on a point of personal expression and states:

"We have been asked to support a so-called Neighborhood Improvement Program. With this so-called Neighborhood Improvement Program, we will be borrowing \$50 million dollars. But for 21 years we will have to pay back over \$91 million dollars. Each year we will have to pay back \$4.3 million dollars to the bond holders. In just six years, we will have paid back over half of the fifty million and still owe the bond holders over \$65 million dollars. We borrow \$50 million and after paying for six years we still owe over \$65 million. Math has never been my strong suit. But common sense is something that I believe have I and my common sense tells me that we would be better off if we just lower our sights on what can be done and if the administration seems to think we have an extra \$4.3 million that we can

spend each year, then we set up a six year improvement program using the \$4.3 million, a six year program that would cost a total of \$26 million dollars. This program may not be as grandiose as the \$50 million proposal, but the job will get done and we will not be paying \$41 million dollars in interest to the bond holders, nor will we be leaving future taxpayers any more debt. I again want to question the cities painting of private homes and the replacing of sidewalks. This has always been a landlords responsibility. If landlords need help, the City could grant low interest loans, not pay the tab. Remember that no matter how much money is put into these programs only some of the tax payers will get their homes painted and their sidewalks replaced, but all the tax payers will have to pay. I will not be supporting this bond issue and I will do all that I can to see it defeated."
