

Beverly Loebenberg, in recognition of best wishes on her retirement from the Providence School Department after 16 years of dedicated service as an educator.


Mary Marinelli, in recognition of the celebration of her 100th birthday, born on October 12, 1908 and wishing her many more years of happiness and good health.
