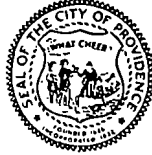

ORDINANCE SECOND READING

The following Ordinance was in City Council June 1, 2000, Read and Passed the First Time and referred back to the Committee on Finance and is returned for Passage the Second Time, as amended:

An Ordinance to authorize the issuance of General Obligation Bonds of the City of Providence in an amount not to exceed \$6,825,000 to finance the payment of the City's portion of the judgment in the case of *Capital Properties, Inc. v. State of Rhode Island* and for no other purpose and to appropriate \$6,825,000 to pay such judgment, as amended.

Be it ordained by the City of Providence:

Section 1. The Sum of \$6,825,000 is appropriated to finance the payment of the city's portion of the judgment in the case of *Capital Properties, Inc. v. State of Rhode Island* and all costs incidental and related thereto and for no other purpose.

Section 2. Pursuant to Rhode Island General Laws § 45-12-4.4, as amended by "An Act making revised appropriations for the support of the state for the fiscal year ending June 30, 2000" (the "Supplemental Appropriations Act"), the City Treasurer with the approval of the Mayor, is authorized to issue and refund general obligation bonds of the City in an amount not to exceed \$6,825,000 (the "Bonds") in order to meet the foregoing appropriation. The said officers shall issue the Bonds in an amount not in excess of the amount required to finance the judgment including interest and costs of issuing bonds.

Section 3. The said officers from time to time may issue and refund not exceeding \$6,825,000

interest bearing or discounted notes in anticipation of the issue of said Bonds.

Section 4. The estimated maximum cost of the judgment described in Section 1 hereof is \$6,825,000, which entire amount is being appropriated hereby.

Section 5. It is hereby determined that the net debt of the City of Providence after the issuance of the Bonds authorized hereby will be \$111,060,000.

Section 6. It is hereby declared that the Bonds authorized hereby will be within all debt and other limitations prescribed by the Constitution and laws of the State of Rhode Island.

Section 7. The manner of sale, forms, amount, denominations, conversion or registration privileges, interest rates, and other conditions and details of the bonds and notes authorized herein shall be fixed by the said officers. Pursuant to the provisions of § 45-12-4.4, as amended by the Supplemental Appropriations Act, the payment of principal of the Bonds shall be sufficient annual payments that will extinguish the debt maturity, the first of these annual payments to be made not later than one year, and the last payment not later than fifteen (15) years after the date of the Bonds.

Section 8. The City Council hereby authorizes the City Treasurer, with approval of the Mayor, to issue the Bonds for the purposes set forth herein and to take all actions as he deems necessary to effect the issuance of the Bonds. The Bond shall be issued by the City under its corporate name and seal or a facsimile of such seal. The Bonds shall be signed by the manual or facsimile signature of the City Treasurer and the Mayor.

Section 9. The City Treasurer and the Mayor are hereby authorized to issue the bonds and deliver them to the purchaser and said officers and hereby authorized and instructed to take all actions, on behalf of the City, necessary to ensure that interest on the Bonds will be excludable from gross income for federal income tax purposes and to refrain from all actions which would cause interest on the Bonds to become subject to federal income taxes.

Section 10. The City's Finance Director is authorized to execute and deliver continuing disclosure certificates in connection with the Bonds or notes issued by the City, in such form as shall be deemed advisable by the City's Finance Director. The City hereby covenants and agrees that it will comply with and carry out all of the provisions of each continuing disclosure certificate, as it may be amended from time to time. Notwithstanding any other provision of this Ordinance or the Bonds or notes, failure of the City to comply with any continuing disclosure certificate shall not be considered an event of default; however, any bondholder or noteholder may take such actions

as may be necessary and appropriate, including seeking mandate or specific performance by court order, to cause the City to comply with its obligations under this Ordinance and under any continuing disclosure certificate.

Section 11. Any balance of bond proceeds remaining after payment of the costs authorized in Section 1 hereof shall be applied to the principal of or interest on the Bonds authorized hereunder.

Section 12. This Ordinance shall take effect upon the later of (a) its date of passage, or (b) the date of enactment of the Supplemental Appropriations Act.

Resolution Supporting the "National Campaign to Fully Fund IDEA" — Individuals with Disabilities Education Act.

Whereas, The National Campaign to Fully Fund IDEA (NCFEI) is a national, nonpartisan, collaborative, grassroots effort made up of parents, school board members, educators, school administrators, business leaders, disability organizations, advocates, students and public servants working together to

improve education for all children in America, and

Whereas, The Individuals with Disabilities Education Act (IDEA) was designated to ensure that all children with disabilities have available to them a free appropriate public education that emphasized special education and related services designed to meet their unique needs and prepare them for employment and independent living, and

Whereas, Provision of these services, while ethically and educationally sound, places a financial burden on local education budgets, and

Whereas, The members of the North Smithfield Special Education Local Advisory Committee is circulating a petition to collect one million signatures of individuals who support a commitment by the Federal Government to provide state maximum grants of 40% of the average per-pupil expenditure in public and private elementary schools throughout the country.

Now, therefore, be it Resolved, That the Members of the Providence City Council hereby supports this petition and encourages the federal government to accept financial responsibility for the IDEA mandates.

Now, therefore, be it further Resolved, That the City Clerk is directed to send this resolution to all members of the Providence legislative delegation asking for their support.

Resolution Requesting an extension of Resolution No. 70 declaring a moratorium in the area of Westminster Street on the issuance of building permits for construction, and demolition permits by the Director of the Department of Inspection and Standards, and a moratorium on the granting and relief from the provisions of the Zoning Ordinance by the Zoning Board of Review.

Whereas, The City Council adopted Resolution No. 70 declaring a moratorium in the area noted below on Westminster Street, on the issuance of building permits for new construction, and demolition permits by the Director of the Department of Inspection and Standards, and a moratorium on the granting of relief from the provisions of the Zoning Ordinance by the Zoning Board of Review.

Whereas, Resolution No. 70 commenced on February 18, 2000 and will expire on August 18, 2000, and

Whereas, The City Council has a pending zoning ordinance amendment that will establish an "Overlay District" to guide the development of properties in the said area described below, and

Whereas, The City Council finds that the West Broadway neighborhood and especially the area of Westminster Street which extends from Interstate Highway 95 to Olneyville Square which is congested with a high volume of traffic, and

Whereas, The City Council finds that the high volume of traffic along Westminster Street poses a serious threat to public safety in that both pedestrians and the motoring public may become victims of serious bodily injury, and

Whereas, The City Council finds that the existing zoning and development provisions may be inadequate and/or inappropriate to provide for the safety of pedestrians and the motoring public along Westminster Street, and

Whereas, The City Council finds that in an effort to address the effects which current zoning and development provisions along Westminster Street may have on the safety of pedestrians and motorists, it has enlisted the West Broadway Neighborhood Association to develop and propose a plan to address the zoning, development and traffic issues in the Westminster area, and

Whereas, The City Council finds that the West Broadway Neighborhood Association shall be assisted by the Department of Planning and Development in formulating their plan, and

Whereas, The City Council finds that the Department of Planning and Development has made specific recommendations to the City Council including revisions to the City Plan and Zoning Ordinance,

Now, therefore, be it Resolved, That the City Council extends and continues the moratorium established by Resolution No. 70 on the issuance of building permits for new construction, and demolition permits by the Director of the Department of Inspection and Standards, and a moratorium on the granting of relief from the provisions of the Zoning Ordinance by the Zoning Board of Review, for a period of one month following the expiration date (August 18, 2000) prescribed in Resolution No. 70. The new expiration date of this moratorium extension is September 18, 2000. The moratorium is for the area described as follows:
